IMPORTANT NOTE FOR CANDIDATES WHO DID NOT DEPOSIT RS. 2500/- AS APPLICATION FEE.

All the Candidates who have appeared in the NCET 2026 Examination but not registered on the GGSIPU University Portal and not paid the Application Fee of Rs.2500/- for Admission in the Programme BA B.Ed. (161) for the Academic Session 2026-27". Such candidates if interested in participating in the counseling shall **be required to visit the University on the above dates along with the required documents and a Demand Draft of Rs.2500/- in favour of "Registrar, GGSIP University", payable at Delhi, for getting registered & Verification of Documents.**

Important:

1. It is mandatory for all registered candidates in Programme BA B.Ed. to report for Verification of Documents.
2. The final merit list will be prepared after verification of documents of all the reported candidates.
3. In case, a candidate/representative does not appear for document verification, the candidature of such candidates would be forfeited and the candidates shall not be considered for admission and will lose their claim to participate in the counseling for admission.
4. Candidates are requested to adhere to the displayed schedule for reporting.
5. Candidates must fulfill the eligibility conditions as laid down in the Admission Brochure 2026-27.

Eligibility Criteria:-

The Candidate who has passed the class 12th/ equivalent examination (Pre- University, Intermediate) with minimum 50 % Marks in aggregate or an equivalent grade from recognized Board/University.

No Result Awaited candidates will be included in the merit.

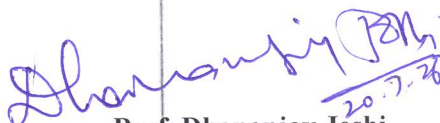
6. The Tentative Merit List of reported candidates will be displayed on **24.07.2026**.

7. Documents required for verification at the time of reporting:

Candidates need to bring the required documents both in photocopy and originals. The photocopies will be retained by the University and the originals will be returned to the candidates after verification.

- a. Copy of GGSIPU Online Registration Form
- b. Class X certificate for verification of DOB. (Photocopy and Original)
- c. NTA Score Card. (Photocopy and Original)
- d. Certificate of Qualifying Examination (i.e. 10+2 OR 10+3 years diploma recognized by the Central / State Governments OR International Baccalaureate Diplomas). (Photocopy and Original)
- e. Reserved Category Certificate: All reservation category candidates who are seeking admission in reserved category in SC/ST/OBC/DEF/PWD/JKM must bring their reservation certificate in original along with the self attested photocopy of the certificate for claiming seat against the reserved category as per the reservation policy and information published in the Admission Brochure 2026-27. The Defence Category candidates in addition, shall also bring Appendix (1) duly completed. The Appendices are available in Part F of Admission Brochure 2026-27. (Photocopy and Original)
