SCHEDULE FOR SPOT ROUND 3 (OFFLINE) COUNSELLING FOR Integrated BA- LL.B. (Hons.) & Integrated BBA- LL.B. (Hons.) (Code 121) and Master of Law (LL.M.) (Code 112) PROGRAMMES through NLT/CUET (ONLY FOR REGISTERED & NOT ADMITTED CANDIDATES) for the Academic Session 2026-27

1. This is continuation to University Notification No. No. 209/2026, F. No. GGSIP/DI(Academic)/Misc/2026/2781 dated 22.08.2026 whereby Commencement of SPOT Round 3 (offline) was postponed, which was earlier scheduled to commence from 23.08.2026 onwards/
2. Now, this is for information to all the candidates that the "SPOT ROUND 3 (OFFLINE) COUNSELLING" will be carried out for the Seats Remained Vacant, for the given below programmes.

3. Eligibility to Participate:- Already "Registered" and "Not Admitted" candidates are eligible to participate in this round of offline counselling.
4. During the course of SPOT ROUND 3 (OFFLINE) COUNSELLING, the allotment of seats shall be carried out irrespective of Region and Category on All India basis. Allotment of seat shall be in the Order of Priority of applicable NLT followed by CUET. It is reiterated that First priority will be given to respective NLT/CET (whichever applicable) Candidates for filling up of vacant seats. After exhausting CET/NLT applicants, the remaining seats will be offered to the CUET candidates in the order of merit.
5. Physical presence of the candidate is mandatory at the time of Offline Counselling, except for medical reasons. IN CASE OF ANY IMPERSONATION THE SAME SHALL RESULT INTO FORFEITURE OF CANDIDATURE.
6. Fee
Demand Draft/Bank Draft(s) of Rs. 96,000/- towards Part Academic Fee is required, which is mandatory at the time counselling in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his name, date of admission, phone, address, mobile no, name of the programme, CET Rank and CET Application Number on the back of the Bank Draft(s). Balance fee (if applicable) shall be paid by the candidate at the allotted institute.

Important Note:

FEE PAID BY THE CANDIDATE DURING ONLINE COUNSELLING SHALL NOT BE ADJUSTED IN THIS ROUND OF OFFLINE COUNSELLING.

7. Documents Required for Verification and Allotment of Seats (alongwith a set of photocopies):
 - a) Four passport sized photographs
 - b) CET Rank Card/Merit Order of CET-2026 (copy)
 - c) CET-Admit Card (in original) 2026.
 - d) CUET Admit Card (whichever is applicable)
 - e) CUET Score Card 2026 (whichever is applicable)
 - f) Online Filled Registration Form (whichever is applicable)
 - g) Filled Admission verification form as per Appendix 5 of Part F of Admission Brochure 2026-27
 - h) Filled Preference sheet as per Appendix 10 of Part F of Admission Brochure 2026-27.
 - i) Proof of date of birth (10th Class Mark-sheet & Certificate) (Original and Photocopy)
 - j) Mark-sheets / Certificates of qualifying examination:

The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination.

k) **Physical Fitness Certificate:**

All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2026-27 (As per Appendix 4).

l) **Conduct and Character Certificate** from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06 (six) months old.

8. During the SPOT ROUND 3 (OFFLINE) COUNSELLING, the University shall ensure that allotment of seats in respective programme in any USS/College/Institute is purely on merit basis.
9. Merit List prepared on the basis of CUET Score is already available on the University Website.
10. College once allotted in this Round of Counselling will not be changed subsequently.
11. It will also be the sole responsibility of the candidate to ascertain and make sure that he/she possesses the requisite eligibility and qualifications prescribed for admission in a particular course as stated in the UG/PG Admission Brochure 2026-27
12. SPOT ROUND 3 (OFFLINE) COUNSELLING will be conducted only for **"REGISTERED"** and **"NOT ADMITTED"** candidates in various Programmes. It is stated that the candidates should not be in possession of a seat (in that particular programme where one is desirous of seeking admission).

13. Who is not eligible for this SPOT Round 3 (OFFLINE) Counselling

(a) **"ADMITTED"** Candidates are **NOT ELIGIBLE** and no fresh registration will be permitted in this Round of offline counseling.

(b) Students admitted under **MANAGEMENT QUOTA** are also **NOT ELIGIBLE**.
