- ❖ NLT - The Candidates who are JEE- Advance, JEE-Main, NEET qualified, who wish to seek exemption from CET, may give an application in writing in the office of Dean, University School of Basis & Applied Sciences, before the last date of submission of application form.
- ❖ NET - The Candidates who are GATE, UGC-NET, CSIR-NET qualified, who wish to seek exemption from CET, may give an application in writing in the office of Dean, University School of Basic & Applied Sciences, before the last date of submission of application form.

2. Registered candidates who did not report after seat allotment in regular round or withdrawal after getting admitted or whose admission got cancelled (due to any deficiency/reason) or were not allotted any seat during the Offline rounds will be eligible in the spot round offline against the available vacancies only). Thus, admitted candidates are not eligible and no fresh registration will be permitted in this round of offline counselling.

3. For Eligibility Criteria please refer UG & PG Admission Brochure 2026-27 available on the University website Candidates are advised to go through the same.

4. Documents Required for Verification and Allotment of Seats (alongwith a set of photocopies):

- a. Demand Draft/Bank Draft(s) of Rs. 96,000/- towards part academic fee is required, which is mandatory at the time counselling in favour of Registrar, Guru Gobind Singh Indraprastha University, payable at Delhi. The candidate will write his name, date of admission, phone, address, mobile no. name of the programme, CET Rank and CET Application Number on the back of the Bank Draft(s). Balance fee (if applicable) shall be paid by the candidate at the allotted institute.
- b. Four passport sized photographs
- c. CET Rank Card/Merit Order of CET-2026 (copy)
- d. CET-Admit Card (in original) 2026.
- e. CUET Admit Card (whichever is applicable)
- f. CUET Score Card 2026 (whichever is applicable)
- g. Online Filled Registration Form (whichever is applicable)

- h. Filled Admission verification form as per Appendix 5 of Part F of Admission Brochure 2026-27
 - i. Filled Preference sheet as per Appendix 10 of Part F of Admission Brochure 2026-27.
 - j. Proof of date of birth (10th Class Mark-sheet & Certificate) (Original and Photocopy)
 - k. **Mark-sheets / Certificates of qualifying examination:**
The candidate will be required to bring the Original certificates/Mark-sheets of all the year wise or semester wise in original along with photocopy of Certificates/ Mark-sheets of qualifying examination.
 - l. **For Distance / Open Learning Cases:**
In case of students who have passed the qualifying examination through distance / open education system of any recognized University / Board / Institution, the necessary documentary evidence related to location of his / her study centre i.e. study centre proof, certificate from the University imparting open / distance education certifying the location of the study centre to be submitted.
 - m. **Physical Fitness Certificate:**
All the students shall be required to submit a Medical Certificate indicating fitness from a Registered Medical Practitioner as per format given in Performa of Medical Certificate in given in Part-F in Admission Brochure 2026-27 (As per Appendix 4).
 - n. **Result Awaited:**
Candidates seeking admission as result awaited candidate must have to submit Appendix 3 of Part F of Admission Brochure 2026-27.
 - o. Conduct and Character Certificate in original from the Head of the Institution from where the qualifying examination has been passed or from Gazetted officer in Original, not more than 06(six) months old.
5. During the course of Extended Open House of Offline Counselling, the allotment of seats shall be carried out irrespective of region and category on All India basis. Allotment of seat shall be in the Order of Priority of applicable CET/NLT followed by CUET. It is reiterated that First priority will be given to respective NLT/CET (whichever applicable) Candidates for filling up of vacant seats. After exhausting CET/NLT applicants, the remaining seats will be offered to the CUET candidates in the order of merit.
 6. The conduct of the Extended Open House of OFFLINE Counselling is to facilitate those candidates only who have not been able to get admission for certain reasons in the Online Counselling Process held so far.
 7. **Physical presence of the candidate is mandatory at the time of Offline Counselling, except for medical reasons.**
 8. During the Extended Open House of OFFLINE Counselling, the University shall ensure that allotment of seats in respective programme in any USS/College/Institute is purely on merit basis.
 9. Merit List prepared on the basis of CUET Score shall be displayed at the time of counselling.
 10. College once allotted in this Round of Counselling will not be changed subsequently.
 11. It will also be the sole responsibility of the candidate to ascertain and make sure that he/she possesses the requisite eligibility and qualifications prescribed for admission in a particular course as mentioned in the UG/PG Admission Boucher 2026-27.
