It is to for information for all the concerned candidates/ stakeholders that the counselling for the programme Lateral Entry to Bachelor of Pharmacy (L.E. to B.Pharm) (CET Code 138) has been scheduled, as per the details given below:

*Candidates are directed to go through the General Important Instructions for claiming the seats earmarked for various Reserved Categories uploaded on University Website vide Notification No. 30/2026, F.No.IPU-7/DI (Academic)/Misc./2026/456 dated 13.05.2026.*

**NOTE FOR CET 2026 QUALIFIED CANDIDATES:**

The seat(s) shall be offered to the qualified candidate(s) in order of merit with respect to his/her Region (Delhi/Outside Delhi) and along with the applicable Reservation (GEN/SC/ST/PWD/DEF/OBC/EWS) provided he/she reports for counselling/ allotment of seat at the venue on the specified date & time.

**FEE:**

The candidates will mandatorily have to pay the Part Academic Fee of Rs. 96000/- in the form of Demand Draft in favour of Registrar, GGSIPU, payable at New Delhi at the time of allotment of seat at the counselling venue. The balance fee, if any, is to be paid by the candidates at their allotted college/institute.

**ELIGIBILITY:** Pass in D. Pharma course from an institution approved by the PCI u/s/ 12 of Pharmacy Act, 1948.

**SEAT MATRIX:** will be notified at the counselling venue.

**RESERVATION:** Refer Admission Brochure 2026-27.

**IMPORTANT NOTE:**

*With regard to Result Awaited candidates, it is made clear that who have 'compartment' as on date in his qualifying examination, will not be considered for admission. They should seek provisional admission only due to non declaration of result of final year/final semester of the qualifying examination by Board/University and not on account of compartment in current or previous years of qualifying degree examination as on date of admission. Result Awaited candidates may please see the provisions contained in Chapter 3 of Part A and Appendix-3 of Admission Brochure for Bachelors Programme).*

*It is the sole responsibility of the candidate to ensure that they fulfill the minimum eligibility criteria in the program they seek admission; the correctness of the details filled with respect to Region; Category/Sub-Category or any other such details for allotment of seat. If at any stage of admission procedure the information furnished by the candidate is found to be incorrect or false, the admission in the programme shall be cancelled and all the fees paid will be forfeited.*

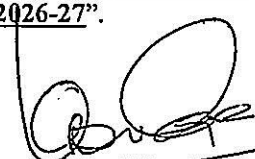
