Eligibility to participate in this Round

- (1) 'Not Registered' Candidates (which have been defined in the Notification No. 237 and have submitted offline application forms in the University's Facilitation Centre on 08.09.2026 and 09.09.2026).

- (2) 'Registered and Not Admitted' candidates who have submitted 'Consent' on the designated e-mail (in consonance with the University's Notification No. 242/2026).

Tentative Merit Lists

Tentative Merit Lists for the above programmes shall be uploaded on the University Website.

Schedules Follows :-

1. The allotment of seats shall be in the order-of-priority of applicable NLT/CET followed by CUET. First priority will be given to respective NLT/CET (whichever applicable). Thereafter, the remaining seats will be offered to the CUET candidates in the Merit List displayed.
2. Physical presence of the candidates is mandatory at the time counseling, except for medical reasons. Impersonation shall lead to forfeiture of candidature.
3. Demand Draft of Rs.96,000/- (ninety six thousand only) in the name of 'Registrar, Guru Gobind Singh Indraprastha University', payable at Delhi shall be submitted by the candidate on the spot after taking a seat in the counseling.
4. Fee paid by the candidate during Online Counselling will not be adjusted in this round.
5. Documents required at the time of counseling (alongwith a set of photocopies):-

 - (b) CET Rank Card / NLT Score Card / CUET Rank Card (as applicable)
 - (c) Appendix 5 – Admission Verification Form

Reporting of the candidates

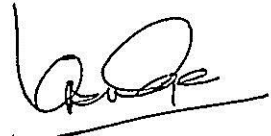
The candidates will immediately report to their allotted college and submit the balance academic fee there.
