**FILLING UP OF VACANCIES VIS-A-VIS SCHEDULE OF ACTIVITIES IN PURSUANCE TO
ORDER DATED 14.09.2026 OF DIRECTOR, DIRECTORATE OF HIGHER EDUCATION,
GOVT. OF NCT OF DELHI,
TO BE FOLLOWED BY AFFILIATED INSTITUTES/COLLEGES:
ACADEMIC SESSION 2026-2027**

This is in reference to Order dated 14.09.2026 digitally signed by the Director, Directorate of Higher Education, Govt. of NCT of Delhi. The relevant extracts of the Said Order dated 14.09.2026 are reproduced below:-

"The recommendations in the Interim Report of the Sub-Committee constituted vide Order No. DHE.4(60)/Policy/2014-15/466-469 dated 27.04.2026 were duly approved by the Government of NCT of Delhi, wherein one of the recommendations duly accepted is to develop a mechanism by the Directorate of Higher Education for filling up of vacant seats of the affiliated Colleges/Institutions after completion of all rounds of admission counselling by the designated agency, i.e. GGSIP University".

"In exercise of the powers conferred under Section 17 read with clause (g) of Section 3, and Section 13 of The Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and other Measures to Ensure Equity and Excellence) Act, 2007 (Delhi Act 08 of 2007), the Government of NCT of Delhi hereby orders the following interim measures, applicable for Academic Session 2026-27, for filling up of vacant seats remaining after completion of the prescribed admission/counselling process by the GGSIP University, which was appointed as the designated agency under the said Act vide order dated 5th May, 2011..".

The Schedule of activities, in consonance with the above said Order, to be followed by Self Financing Institutions is as under:-

Para No. 1	<i>The affiliated Colleges/Institutions of GGSIP University shall be permitted to conduct admissions to fill the available vacant seats of the sanctioned intake, after completion of all rounds of online/offline counselling conducted by the designated agency, i.e. GGSIP University strictly in transparent manner on the basis of merit in National Level Test/CET/CUET, from the qualified candidates, who were somehow unable to get admission during the counselling conducted by the designated agency.</i>	The Self Financing affiliated colleges are advised to comply with the Order dated 14.09.2026 of the Directorate of Higher Education, Govt. of NCT of Delhi in toto and adhere to all the conditions stipulated therein.
Para No. 2	<i>Self-financing affiliated Institutions will have to issue a public advertisement, in at least two national level daily newspapers with explicit 5 days duration for the qualified candidates to apply to the College/Institute of his/her choice for admission. The institution shall publish the vacancies, eligibility criterion and counselling schedule on its website.</i>	Advertisement in atleast two National Level daily newspaper to apply from 19th September, 2026 to 23 rd September, 2026 (05 days). The Institutions shall publish the vacancies, eligibility criteria on their website on 19.09.2026. The schedule of Ist Round of Counselling will be displayed on 23.09.2026 on their website/Notice Board.

Para No. (3)	<i>The affiliated Colleges/Institutions in first round of admission counselling will have to admit the students on the basis of merit of the eligible candidates, who have already registered with the designated agency i.e. GGSIPU other than already admitted candidates.</i>	Merit List to be displayed by the Self Financing Institutes on their website and Notice Board on 24 th September, 2026. Conduct of Ist Round of Counseling by the Self Financing Institutes on 25.09.2026.
Para No. (4)	<i>In case, if seats as per sanction intake still remain vacant, the affiliated Colleges/Institutions may conduct subsequent round of admissions counselling by permitting fresh eligible candidates, not having being admitted so far and who were unable to register earlier with the designated agency by inviting fresh application online for which not more than 3 days time may be allowed.</i>	The Self Financing Institutes are required to display/upload vacant seats programme-wise on their Institutional website/Notice Board on 26.09.2026 pursuant to conclusion of Ist Round of Counselling. Issuance of Notification for conduct of subsequent round, on the college website; and, for inviting fresh applications through "online mode" from 26.09.2026 to 28.09.2026. Merit List to be displayed by Self Financing Institutes on their website and notice Board on 29.09.2026 Subsequent Round of Counselling by the Self Financing Institutes on 30.09.2026.
Para No. (6)	<i>Every admission shall be uploaded/reported to the designated agency within the prescribed period. After completion of the process of direct admissions at College/Institute level, the list of such admitted candidates shall be submitted to the designated agency for issuance of enrolment numbers within 07 days of last day of admission process.</i>	If all the seats are filled during the first round of Counselling, the list of admitted candidates will be provided to Designated Agency on 26.09.2026. otherwise, the list will be provided after the completion of subsequent round of counselling on 30.09.2026.

The affiliated colleges are advised to comply with all the points of Order dated 14.09.2026 of the Directorate of Higher Education, Govt. of NCT of Delhi in toto and adhere to all the conditions stipulated therein alongwith the conditions laid down in the relevant UG/PG Admission Brochure 2026-2027 and norms of the applicable Statutory Bodies like AICTE, UGC, Bar Council etc.

In addition to above, the Affiliated Institute may constitute an Admission Committee comprising of Director/Principal/Chairman with two regular faculties of their Institutes/College to oversee the whole admission process of their Institute/College.

The University shall designate a Nodal Officer for co-coordinating and monitoring the implementation of this mechanism for admissions by the affiliated Colleges/Institutions.
