<b>Information Sought :</b>	<p>Subject: Regarding the e gazette notification for name change from Kanta Kumari to Pooja Preenja issued in part four of e gazette page no. 837 on May 27, 2017.</p> <p>Sir,</p> <p>It is submitted as under:</p> <ol style="list-style-type: none"> <li>1. That my wife, Kanta Kumari d/o Sh Shanti Swaroop Sharma applied for name change due to which gazette notification was issued on the completion of the process as mentioned in the subject.</li> <li>2. That all the legal formalities like preparation of Affidavit and public notices in two newspapers were inserted and no fact was concealed.</li> <li>3. That the wording on the newspapers reads, I, Kanta Kumari d/o Shanti Swaroop Sharma, wife of Vijay Kumar Preenja, F9/1861A, Jagdambay Colony, Street no 1, Batala Road, Amritsar have changed my name to Pooja Preenja. Concerned may note.</li> <li>4. That the wording on the affidavit reads, I, Kanta Kumari d/o Shanti Swaroop Sharma, wife of Vijay Kumar Preenja, R/o, F9/1861A, Jagdambay Colony, Street no 1, Batala Road, Amritsar, Punjab, India do hereby solemnly affirm and declare as under:             <ol style="list-style-type: none"> <li>a) That I am permanent resident of the above said address.</li> <li>b) That previously my name was Kanta Kumari and after my marriage with Sh Vijay Kumar Preenja on OCT 15, 1985, my name has been changed as Pooja Preenja.</li> <li>c) I state that Kanta Kumari and Pooja Preenja is the name of the one and the same person and that is myself. That now my name is Pooja Preenja and will be used for all practical purposes in future, in the government and non government and other sectors.</li> </ol> </li> <li>5. However, the notification issued by your goodself in the e gazette regarding name change is not complete. You have made a mention of name of father of Kanta Kumari/Pooja Preenja ( as Shanti Swaroop Sharma) but failed to highlight name of husband ( as Vijay Kumar Preenja) thus completely ignoring the wording published in newspapers and in the affidavit. The same wording has been incorporated in para 3 and 4 of this document also for your perusal. And exactly from here my problems have started.</li> <li>6. That the cause of action arose when the passport authorities refused to update name of my wife on my passport on 28th Feb, 2023 on the ground that the supporting document, egazette notification fails to mention the name of husband. According to them (the passport authorities) it should be Pooja Preenja wife of Vijay Kumar Preenja instead of Pooja Preenja d/o Shanti Swaroop Sharma.</li> <li>7. I, therefore, request your goodself to rectify the omission and issue me the new egazette notification of my wife immediately, mentioning either both the names (names of father and husband) or only name of husband such that I may complete my process of Passport renewal and updation.</li> <li>8. Otherwise, provide me the information under RTI Act for publishing incomplete e gazette notification thus setting aside the newspaper as well as the affidavit wording and putting me to unnecessary harassment.</li> </ol> <p>Kind regards Vijay Kumar Preenja Mo: 8146585186</p>
