



The temple consists of a portico supported by two elegantly carved pillars, main hall, antechamber and main shrine with a figure of Paraswanath with five-hooded canopy over his head. The outer wall of the temple i.e. niche is highly decorated with fine sculptures with minute details particularly mithuna couples in bas-relief and almost all the figures on the wall are Digamber Jains. Some are converted into the faith of Hinduism with manifestation of Vishnu and Shiva showing the gestures of Veradmudra later.





