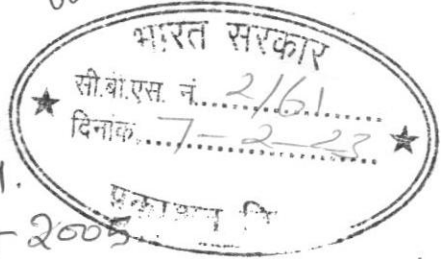

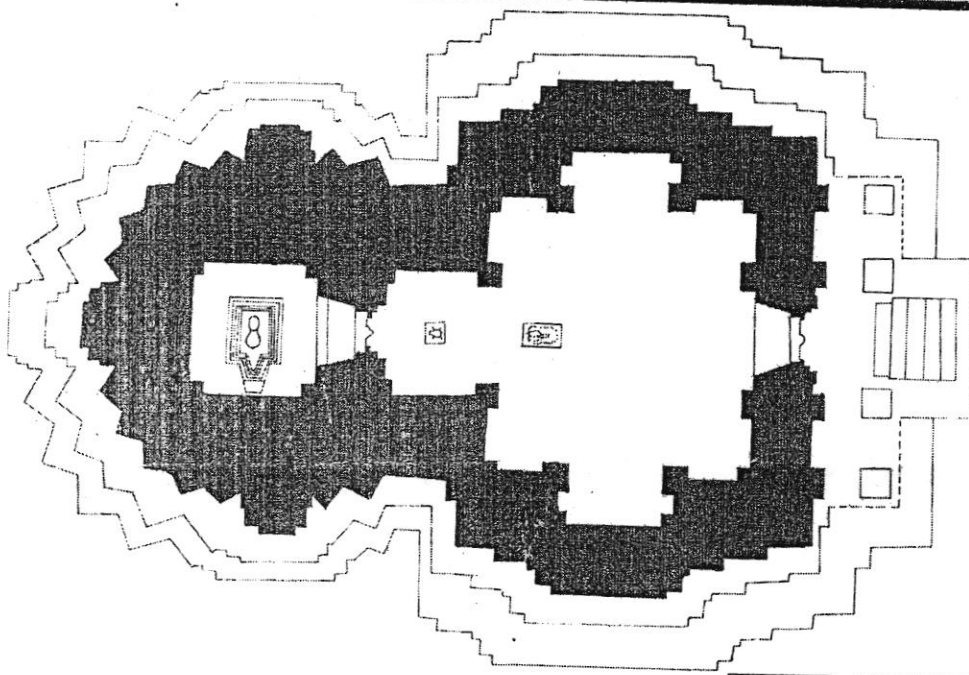
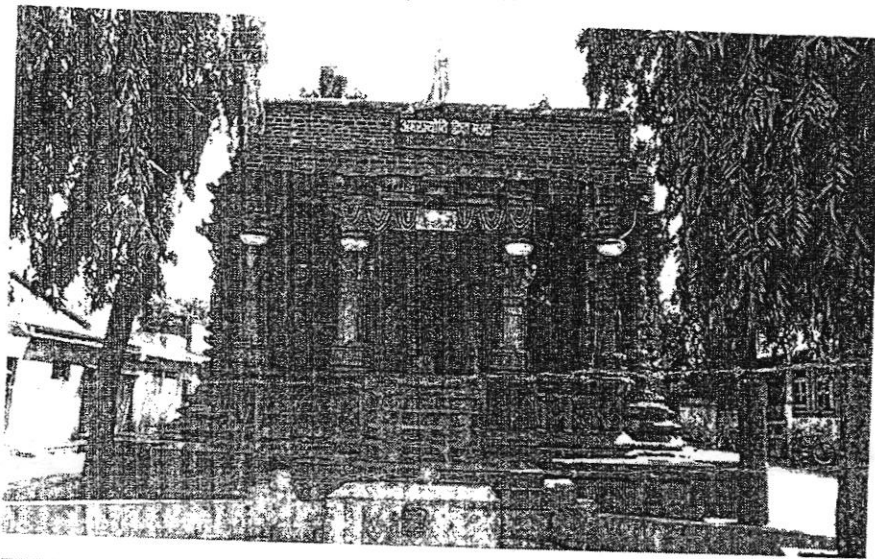

No. 387 - *Education*. - In exercise of the powers conferred by section 3 (3) of the Ancient Monuments Preservation Act, 1904 (VII of 1904), the Chief Commissioner is pleased to confirm Notification No. 8453 - Education, dated the 12th November 1913, which declared the undermentioned monuments to be protected monuments within the meaning of the Act.

Monuments	Locality
1. Tomb of Muhammad Shah known as Mubarik Khan ka Gumbaz.	Khairpur.
2. Tomb of Sikandar Lodi, with its enclosure walls and bastions, gates and compound	Khairpur.
3. Old Lodi Bridge with its approaches	Near Tomb of Sikandar Lodi, Khairpur.
4. Mosque with its <i>dalans</i> and courtyard and the Bara Gumbaz (the domed entrance to the mosque).	Khairpur.
5. Unknown tomb with blue tile decoration known as Shisha Gumbaz.	Khairpur.
6. The Qutb archaeological area as now defined including the iron pillar, Minar of Qutub, Dargah, all colonnades, serais, gates, tomb of Altamash, college buildings of Alauddin, tomb of Imam Zamin and all carved stones in the above area with gardens, paths and water channels and all gate ways including the Alai Darwaza, also all graves in the above area. 7. Tomb of Adham Khan (Rest House)	Mehrauli.
8. Tomb of Muhammad Quli Khan	South of Qutb Dak bungalow, Mehrauli.

(32) JHABARESHWAR MAHADEO TEMPLE

1. **DISTRICT:** Satara **TEHSIL / SUB-DIVISION:** Phaltan
2. **LOCALITY:** Phaltan (Lat. $17^{\circ} 59'$, Long. $74^{\circ} 25'$)
3. **NOTIFICATION NO.:** 3, dated 02.01.1954
4. **APPROACH:** Airport- Pune, Railway Station- Loanand, Bus station- Phaltan
5. **BRIEF DESCRIPTION:** This monument is datable to the 12th and 13th century and was originally dedicated to the 23rd Tirthankar i.e. Paraswanath. The temple consists of a portico supported by two elegantly carved pillars, main hall, antechamber and main shrine with a figure of Paraswanath with five-hooded canopy over his head. The outer wall of the temple i.e. niche is highly decorated with fine sculptures with minute details particularly *mithuna* couples in bas-relief and almost all the figures on the wall are Digamber Jains. Some are converted into the faith of Hinduism with manifestation of *Vishnu* and *Shiva* showing the gestures of *Varadmudra* later.
6. **TOPOGRAPHICAL FEATURES:** The monument is situated 29Kms from Loanand.
7. **OWNERSHIP** : Central Government

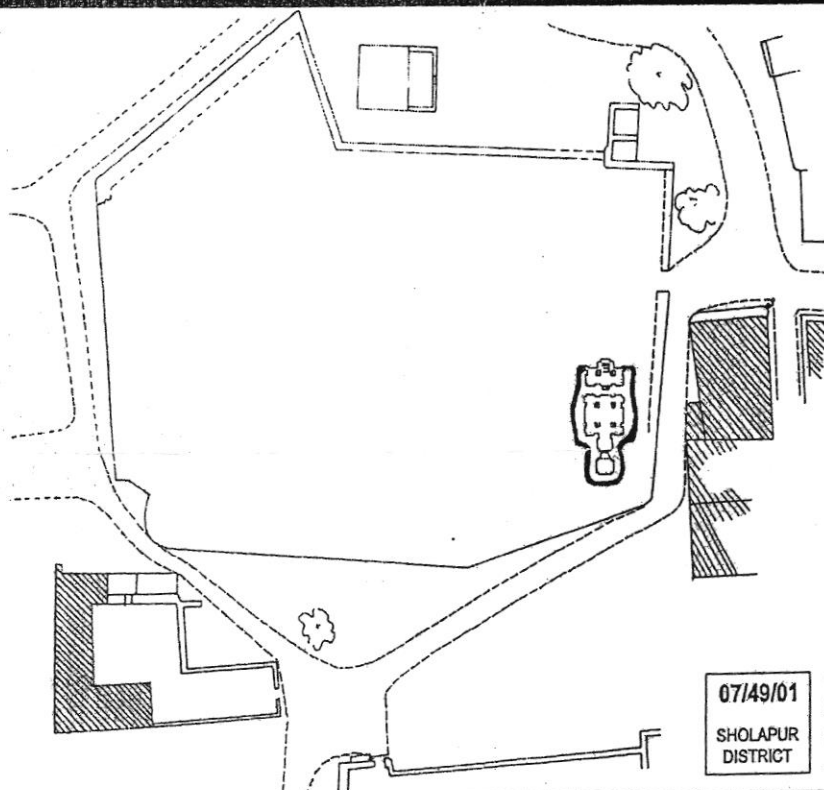
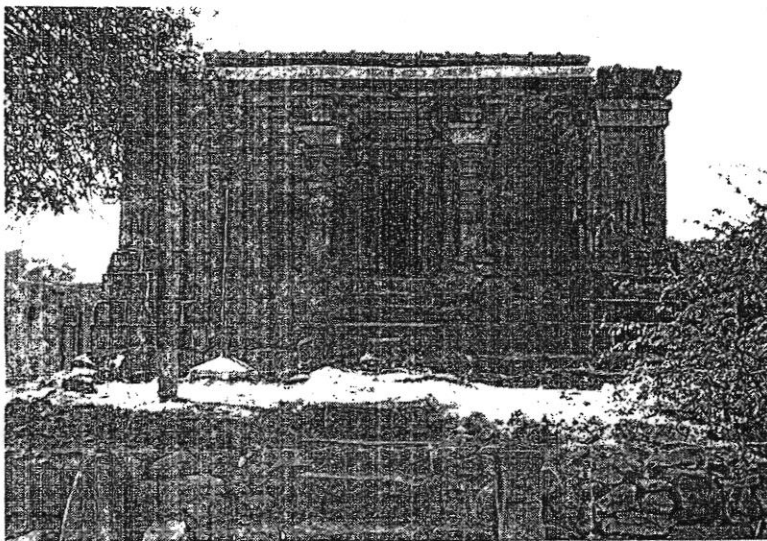

(49) OLD TEMPLE OF SARKARVADA LOCALLY KNOWN AS PARASNATH TEMPLE

1. **DISTRICT:** Sholapur TEHSIL / SUB-DIVISION: Malshiras
2. **LOCALITY:** Velapur (Lat. 17° 25', Long. 75° 03')
3. **NOTIFICATION NO.:** 3807-A, dated 04.12.1930
4. **APPROACH:** Airport- Sholapur, Railway Station- Pandharpur, Bus station- Velapur
5. **BRIEF DESCRIPTION:** The *garbhagriha* is a small square structure with a *shivalinga* in the centre. The interior wall of the *garbhagriha*, which is now filled with debris, may have below an old passage leading to the tank. The colonnade has a flight of steps leading to the tank and 4 pillars and pilasters on either side dividing the colonnade into seven ways, of which the back wall provides niche with sculpture. The pillars of this colonnade confirm to the usual *Hemadpanti* type of *Yadava* period.
6. **TOPOGRAPHICAL FEATURES:** It is situated 45Kms North-West of Pandharpur.
