A. PROPOSED AMENDMENT TO THE BYE LAWS OF THE NATIONAL COMMODITY CLEARING LIMITED

1. Short title and commencement

(1) This amendment shall be called NCCL Bye Laws (Amendment), 2025.

(2) It shall come into force with effect from the date of notification in Gazette of India.

2. The existing clause 2.1.18 of NCCL Bye Laws is proposed to be replaced by the new definition:

2.1.18 "Clearing Member" means a Clearing Member as defined under Section 2(ae) of SEBI (Stock Brokers and Sub-Brokers) Regulations, 1992.

B. PROPOSED AMENDMENT TO THE RULES OF THE NATIONAL COMMODITY CLEARING LIMITED

1. Short title and commencement

(1) This amendment shall be called NCCL Rules (Amendment), 2025.

(2) It shall come into force with effect from the date of notification in Gazette of India.

2. The existing clause 2.1.10 of NCCL Rules is proposed to be replaced by the new definition:

2.1.10 "Clearing Member" means a Clearing Member as defined under Section 2(ae) of SEBI (Stock Brokers and Sub-Brokers) Regulations, 1992.

3. A new clause is proposed to be added under the existing clause 8.9 of NCCL Rules:

8.9A CHANGE IN CATEGORY OF MEMBERSHIP

(1) Subject to provisions of the Bye Laws, Rules & Regulations of NCCL as well as the circulars issued by SEBI or NCCL as in force from time to time, NCCL may consider the request for change in category of membership from Trading Member/Trading Cum Clearing Member/ Strategic Cum Clearing Member/ Professional Clearing Member.

(2) Any request for change in category as per sub clause 8.9A (1) shall be dealt with in a manner as may be notified by NCCL from time to time.

4. The word "Trading Membership" is proposed to be replaced with the word "Clearing Membership" for the purpose of clause 8.6.7 of NCCL Rules:

8.6.7 Without prejudice to any other provision of the Rules, the Clearing Membership/ Membership may be suspended, for such period as the Relevant Authority may deem fit, in the following circumstances:
