- A. Whereas pursuant to the Circular dated June 25, 2024 issued by Securities and Exchange Board of India (SEBI) on "Statutory Committees at Market Infrastructure Institutions (MIIs)", it is proposed to amend the Bye-Laws of BSE Limited (BSE), as under, inviting public comments in terms of Securities Contracts (Regulation) Act, 1956:
- 1) Chapter VII, Bye-law 5(b) - Inviolability of Trade – Notwithstanding anything contained in clause (a) above, ~~the Board or the Managing Director or any other~~ a person(s) /committee(s), ~~as may be~~ authorized by the Board or Managing Director of the Exchange may, suo moto or pursuant to a request received from its member annul the trade(s) or reset the price of the trade(s) to an appropriate price in accordance with regulations/circulars issued by the SEBI and the Exchange from time to time, provided it is satisfied that there exists a cogent and sufficient cause to do so and is in the interest of investors, market integrity and maintenance of price discovery mechanism.
 - 2) Chapter VII, Bye-law 5(e) - Inviolability of Trade - The decision of the Exchange to annul the trade(s) or reset the price of trade(s) is subject to review, on the request of the aggrieved party, by the ~~Independent Oversight Committee on "Trading and Surveillance function" of the Exchange~~ committee as prescribed by SEBI / the Exchange from time to time. The Exchange, in any case, shall not be liable for any losses/liabilities arising out of annulment of the trade(s) or resetting of the price of the trade(s).
