Department of Publication established in April, 1924 and grown as a full-fledged Department over the years is now a subordinate office under the Ministry of Housing and Urban Affairs which is headed by Controller of Publication. It possesses the largest depository of Government of India books consisting of over 8000(Eight Thousand) titles (excluding various periodical, Gazettes notifications and Army Publications). The Controller of Publication is the authorized publisher, custodian and distributer of Government of India Publications. It caters the need of general public as well as government departments in respect of official publications. Department of Publication is having its website viz-www.deptpub.nic.in and egazette.nic.in containing all sorts of information about Government Publications and digitized/e-published form of gazette to facilitate the general public for suo moto disclosure of information. The Gazettes are available in public domain which can be downloaded free of cost. The Department holds the copyright of these publications. It has its own Sales Outlets located in New Delhi, Mumbai, Kolkata and Bangalore and agents spread across the country. The Department is earning revenue through Advertisement published in the Gazette of India, Sale of Books, Gazettes, Periodicals and Publications etc. It has statutory function to issue the symbol Numbers for Government of India Publications in respect of all Ministries, Departments and PSU's.

It has been catering for the needs of book lovers, Research Scholars and People of different strata throughout the world. Over the years, the Department has acquired large number of books which are available on various disciplines and subjects viz-Statistics, Literature, etc. The Amount of revenue earned is deposited to the Consolidated Fund of India.

Organization Structure

The Department of Publication is headed by the Controller of Publications, who is assisted by one Assistant Controller and one Financial Officer.

The Department of Publication comprising of:

- (b) Sale Depot/Outlets:-
 - (i) Sale Counter, Delhi High Court, New Delhi.
 - (ii) Sale Counter at Head Quarter Civil Lines Delhi-110054.

 - (iv) Government of India Book Depot, 8, K.S.Roy Road, Kolkata.
 - (v) Sale Counter at New CGO Complex, New Marine Lines, Mumbai.
 - (vi) Sale Counter, Kendriya Sadan, Koramangala, Bangaluru- 34.

In addition to the Book Depot/Sale Counters, the Publications are being sold through agents spreads across the country.

The Department is responsible for the following main activities:-

- 1. Publishing, Stocking, Sale and Distribution of Government Publication and Periodicals.
 Publishing of Gazette of India.
 - 2. Cataloguing of Publications/Periodicals, issuance of Symbol No. for Govt. of India Publications.
 - 3. Securing advertisements for insertion in Periodicals, Gazette of India Part-IV.
 - 4. Stocking of Army Publications and Distributions to Private/Government agencies and our Sale-Outlets/Book Depot.
 - 5. Timely raising of bills and realization thereof.
 - 6. Participation in Book Fairs/Exhibitions to unfold valuable informative Govt. Publications before the book lovers, research scholars spread across the country/abroad.
