Original RTI Text : This RTI is addressed to DOPT. The relevant file on this matter regarding Definition of Ex Serviceman is held in DOPT office.

The change in Definition of Ex Serviceman which became operative on 15 Nov 1986 through GSR issued on 27 Mar 1987(Copy attached) involved CHANGE IN TERMS AND CONDITIONS OF EMPLOYMENT of officers of the Armed Forces, wherein the expression - those released at their own request after completing 5 years service in the Armed Forces of the Union - was removed which as per Transaction of Business Rules 1961, had to be Cleared through inter-ministerial consultation (DOPT, Law Ministry, Finance, MHA), and placed before the Union Cabinet via the Cabinet Secretariat. Remarks of DOPT Secretary Mr N.Ramanujam in File No 36034/5/85-Estt(SCT) on page No 27 dated 31 May 1986 of noting sheets(copy attached) confirming that this change mandated cabinet approval. This information was shared by DOPT in RTI answer given by Dy Secretary and First Appellate Authority of DOPT dated 24 Nov 2022.

You are requested to provide information as per documents available in DOPT to the following query.

Query - Please share authority based on which a MoS of any ministry has the seniority and power to publish Gazette notification effecting change in Terms and Conditions of Employment of Government Employees (Indian Armed Forces officers, part of MoD in this case).

ORDER

Subject: Appeal No. DOP&T/A/E/22/01084 dated the 30th October 2022 against reply furnished by the CPIO to RTI application Regd. No. DOP&T/R/E/22/02439 dated the 05th May 2022 by Shri Dheeraj Bhargava.

WHEREAS the undersigned is in receipt of an RTI Appeal No. DOP&T/A/E/22/01084 dated the 30th October 2022, preferred by Shri Dheeraj Bhargava, addressed to the First Appellate Authority under RTI Act, 2005 with reference to his RTI request No. DOP&T/R/E/22/02439 dated the 05th May 2022.

AND WHEREAS it has been observed that the CPIO, vide online Communication dated 26th May 2022, had sent a reply with reference to his RTI application dated the 05th May 2022 and provided the relevant note portion in respect of file no 36034/1/2006-Estt (Res.) and file no 36034/5/85-Estt (SCT).

AND WHEREAS the present appeal dated the 30th October 2022 has been filed by citing the grounds for appeal is that the query in RTI has been partially answered. The appellant has requested to provide Pages 1-25 in respect of file no 36034/1/2006-Estt (Res.) and Pages 1-36 of file no 36034/5/85-Estt (SCT).

AND WHEREAS the undersigned as first Appellate Authority after carefully perusing the application of the Appellant has decided to provide the remaining pages of notes portion of the relevant file as requested by the Appellant. Accordingly, the desired pages are enclosed herewith for information.

AND WHEREAS it may be noted that as per the provisions of the RTI Act 2005, the public authority can only provide information, which already exists with the public authority or is held under his control. The Public Information Officer (PIO)/ Central Public Information Officer (CPIO) is not supposed to 'create' information or to 'interpret' information. The Act does not require the PIO/ CPIO to deduce some 'conclusion' from the 'material held or provided' and supply the 'conclusion' so deduced to the Applicant. The CPIO is also not required to give his 'opinion' or 'advice' in any matter to solve problems of the Applicant.

NOW, THEREFORE, in exercise of powers conferred under Section 19 (6) of the RTI Act, 2005, the appeal, made by the applicant, stands disposed off.

A second appeal against the order shall lie with the Hon'ble Central Information Commission, Baba Gangnath Marg, Munirka, New Delhi-110067.

NOTIFICATION

GSR- In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the Ex-servicemen (Re-employment in Central Civil Services and Posts) Rules, 1979, namely :

1. (1) These rules may be called the Ex-servicemen (Re-employment in Central Civil Services and Posts) Amendment Rules, 1987.
(2) They shall be deemed to have come into force on the 15th day of November, 1986.
2. In rule 2 of the Ex-servicemen (Re-employment in Central Civil Services and Posts) Rules, 1979, to clause (c), the following proviso shall be added, namely :

"Provided that for the period commencing on the 15th day of November, 1986 and ending with the 30th day of June, 1987, any person who has been released :

- (a) at his own request after completing 5 years service in the Armed Forces of the Union;
or

(b) after serving for a continuous period of six months after attestation, otherwise than at his own request or by way of dismissal or discharge on account of mis-conduct or inefficiency or has been transferred to the reserve pending such release ;

shall also deemed to be an ex-serviceman for the purposes of this clause."

Note : Principle rules were published vide notification No. GSR - 1530 dated the 29 th December, 1979 and subsequently amended vide notification No. GSR-973 dated 15th November, 1986 in the Gazette of India, Part II- Section 3 -Sub-section (i).
