- Note 4: In Local-Cat-II(B)(O) cadre candidates by name Kaisar Islam, Ibrahim & Mahammed Azhar Saleem, have obtained equal marks (7) in vivo voce. However, as per rule 4(3) of KSC (Ministerial and other posts) (Recruitment) Rules 1982, the candidate Kaisar Islam is selected, since she is elder than the Ibrahim & Mahammed Azhar Saleem.

- Note 3: For Additional List, In Local GM Rural cadre, candidates by name, Sahana Sangappa Merakor and Raveendra have obtained equal marks (8) in vivo voce. However, as per rule 4(3) of KSC (Ministerial and other posts)(Recruitment) Rules 1982, the candidate Sahana Sangappa Merakor is selected for Additional list, since she is elder than the Raveendra.
- Note 4: For Additional List, In SC-(R)-Local Cat, candidates by name, Ambaresh & Shreekanth have obtained equal marks (7.5) in vivo voce. However, as per rule 4(3) of KSC (Ministerial and other posts)(Recruitment) Rules 1982, the candidate Ambaresh is selected for Additional list in this Cat, since he is elder than the Shreekanth.
- Note 5: For Additional List, In Local-Cat-II(A)(W) candidates by name Lalitha A & Pallavi, have obtained equal marks (5.5) in vivo voce. However, as per rule 4(3) of KSC (Ministerial and other posts)(Recruitment) Rules 1982, the candidate Lalitha A is selected, since she is elder than the Pallavi
- Note 6: For Additional List, In Local-Cat-II(B)(O) candidates by name Ibrahim & Mahammed Azhar Saleem, have obtained equal marks (7) in vivo voce. However, as per rule 4(3) of KSC (Ministerial and other posts) (Recruitment) Rules 1982, the candidate Ibrahim is selected, since he is elder than the Mahammed Azhar Saleem
- Note 7: For Additional List, In Local-Cat-III(A) candidates by name Usha Kuberappa Holechara & Lakshmi P, have obtained equal marks (7) in vivo voce. However, as per rule 4(3) of KSC (Ministerial and other posts)(Recruitment) Rules 1982, the candidate Lakshmi P is selected, since she is elder than the Usha Kuberappa Holechara
