# Fresh from the Bench

## *State of Punjab v. Davinder Singh, 2024 INSC 562*

### *Sub-classification of the Scheduled Castes is Constitutionally Permissible*

In the judgment dated 01 August 2024, the seven-judge Constitution Bench comprising the **Chief Justice of India, Dr D Y Chandrachud, Justice B R Gavai, Justice Vikram Nath, Justice Bela M Trivedi, Justice Pankaj Mithal, Justice Manoj Misra and Justice Satish Chandra Sharma** held by a majority of 6:1 that sub-classification of the Scheduled Castes for reservation is constitutionally permissible and clarified that the Scheduled Castes are a socially heterogeneous class wherein the State is empowered under Articles 15(4) and 16(4) to further classify the Scheduled Castes if it fulfils the two-prong intelligible differentia standard under Article 14. The Court added that sub-classification within the Scheduled Castes does not violate Article 341(2) as it is not meant to give exclusive benefit to certain castes or groups over all the reserved seats and the application of the principle to beneficiary classes under Articles 15(4) and 16(4) laid down in *Indra Sawhney* is not limited to the other backward classes. The Court overruled the decision of unconstitutionality of sub-classification of the Scheduled Castes in *E V Chinnaiah*.

**Justice B R Gavai**, in his concurring opinion, added that sub-classification would be permissible only if there is a reservation for a

sub-class as well as the larger class wherein State would have to provide reasons supported by empirical data that the sub-castes that are given beneficial treatment were inadequately represented. He added that the creamy layer principle also applies to Scheduled Castes and Scheduled Tribes; however, its criteria can be different from that of the Other Backward Classes. **Justice Vikram Nath** and **Justice Satish Chandra Sharma** concurred with this opinion on the creamy layer. **Justice Pankaj Mithal** added that the benefit of reservation would not be carried forward to the next generation in a family where the first generation has taken benefit of the same.

**Justice Bela Trivedi** dissented from the majority judgment and observed that the decision in *E V Chinnaiah* should not have been disregarded in the context of doctrines of precedents and stare decisis as the inclusion or exclusion of any caste, race or tribe or part of or group within any caste, race, or tribe is a Parliamentary prerogative and cannot be altered by any subsequent notification by the President. She opined that the “Scheduled Castes” is a homogenous class, which cannot be diluted by the States by sub-dividing or sub-classifying it. She added that the State cannot

vary the Presidential List or Article 341 of the Constitution. She added that the Supreme Court

cannot validate a State action under Article 142 if it violates any Constitutional provisions.

### *Govt of NCT of Delhi v. Office of Lieutenant Governor of Delhi, 2024 INSC 578*

*LG not bound by aid and advice of the Council of Ministers to nominate members to DMC*

In the judgment dated 5 August 2024, a three-judge bench comprising the **Chief Justice of India, Dr D Y Chandrachud, Justice P S Narasimha, and Justice J B Pardiwala** held that the Lieutenant Governor (LG) of the National Capital Territory of Delhi (GNCTD) is empowered to nominate members to the Delhi Municipal Corporation and is not bound by the aid and advice of the Council of Ministers of GNCTD as provided in Article 239AA(4) of the Constitution. The Court

clarified that the discretionary power of LG under Article 239AA(4) is wider than that of the Governor under Article 163. The Court observed that by virtue of the 1993 Amendment to the Delhi Municipal Corporation Act, 1957, the Parliament has limited the executive power of GNCTD. The Court added that Section 3(3)(b)(i) of the Act imposes a statutory duty on the LG to exercise its discretion in nominating persons with special knowledge in DMC.

### *K Arumugam v. Union of India, 2024 INSC 630*

*Lottery sales by the State are not a service, exempting wholesalers from service tax*

In the judgment dated August 8, 2024, the division bench comprising **Justice B V Nagarathna** and **Justice N Kotiswar Singh** held that the sale of lottery tickets by the State Government is not a “service” but a revenue-generating activity. The central issue was whether the wholesalers of lottery tickets who bought them from the State Government in bulk at a discount and resold them to retailers at a margin were liable to pay service tax under the category of “business auxiliary service” as defined in Section 65(19) of the Finance Act, 1994. The Court held that the sale of lottery tickets by the State Government is not a “service” but rather a revenue-generating activity. As a result, the wholesale purchasers of

lottery tickets are not promoting or marketing any service rendered by the State and are therefore not subject to service tax under “business auxiliary service.” The Court observed that once the lottery tickets are sold by the Directorate of Lotteries, the title to the tickets is transferred to the appellants, who then sell them as owners, not as agents of the State. This establishes a principal-to-principal relationship rather than a principal-agent relationship. Furthermore, the Court held that the Explanation added to Section 65(19)(ii) of the Finance Act, 1994, which attempted to include the sale of lottery tickets under “business auxiliary service,” could not override the main text of the provision.

***DLF Ltd. (formerly known as DLF Universal Ltd.) v. Koncar Generators and Motors Ltd., 2024 INSC 593***

*Foreign currency exchange rate of foreign awards is on the date when the award becomes enforceable*

In the judgment dated 08 August 2024, the division bench comprising **Justice PS Narasimha** and **Justice Aravind Kumar** held that the relevant date for deciding the conversion rate of foreign currency in a foreign arbitral award is the date when the award attains finality and becomes enforceable, i.e., when the objections against it are finally decided. The Court decided on the issue of the appropriate date to determine the foreign exchange rate for converting the foreign awards expressed in foreign currency into Indian currency. The Court formulated twin tests, first, following the principle in *Forasol v. Oil and Natural Gas Commission*, the date when the arbitral award becomes enforceable shall be the date for conversion. The Court clarified

that a foreign award is enforceable as a decree of the court under Section 49 of the Arbitration and Conciliation Act, 1996 after the objections against such an award under Section 48 are finally decided and disposed of. Second, as per the principle in *Renusagar Power Co Ltd v. General Electric Co*, pending objection proceedings, when the award debtor deposits an amount and the award holder is permitted to withdraw this amount, the relevant conversion rate shall be as on the date of the deposit. The Court added that this deposited amount shall be adjusted against the remaining amount pending under the arbitral award, and the relevant conversion rate shall be on the date when the award becomes enforceable.

***In Re: Alleged Rape and Murder of Trainee Doctor in R G Kar Medical College Hospital Kolkata and related issues, 2024 INSC 613***

*Constituted a National Task Force to make recommendations for national protocol on safe and dignified working conditions for medical professionals*

In an order dated 20 August 2024, a three-judge bench comprising **Chief Justice of India, Dr Justice D Y Chandrachud, Justice J B Pardiwala, and Justice Manoj Misra** took suo moto cognizance of the rape and murder of a postgraduate doctor at the R G Kar Medical College Hospital, Kolkata and the subsequent vandalization that took place at the protests. The Court flagged certain concerns over the lack of institutional safety norms at medical establishments, including inadequate resting

spaces, lack of conditions of basic wellbeing and security standards, coupled with inadequate transportation facilities and surveillance measures including CCTV cameras and risk of violence and sexual violence against medical professionals. The Court ordered the constitution of the National Task Force (NTF) to make recommendations on the issues pertaining to safety, working conditions, and wellbeing of medical professionals and other cognate matters. The Court further suggested that the

action plan be categorised under two heads (i) Preventing violence, including gender-based violence against medical professionals; and (ii) Providing an enforceable national protocol for dignified and safe working conditions for interns, residents, senior residents, doctors, nurses and all medical professionals. The Court directed NTF to submit an interim report

within three weeks and the final report within two months. The Court further directed the Cabinet Secretary to the Union Government to associate with the work of the NTF. The Court ordered all the State governments and the Union Territories to share data on the working conditions at government-run hospitals under the Union government.

### *Ravi Agarwal v. Union of India, Writ Petition (Civil) No. 706/2020*

*Amendment to Section 80DD of Income Tax Act 1961 applies prospectively, not retroactively*

In an order dated 20 August 2024, a division bench comprising **Justice B V Nagarathna** and **Justice N Kotiswar Singh** rejected retrospective application of an amendment to Section 80DD of Income Tax Act, 1961. The primary issue was whether the amendment, introduced by the Finance Act, 2022, which allows for annuity or lump sum payments to disabled dependants once the subscriber reaches the age of 60, should be applied retrospectively to insurance policies issued before 2014. The petitioner argued for the retrospective application, claiming it would benefit more subscribers and disabled individuals.

The Court emphasised that the core objective of Section 80DD, particularly in the context of the Jeevan Aadhar Policy, was to ensure that disabled dependants receive financial support after the death of the caregiver or subscriber. This policy was designed to prevent a situation where a disabled dependant would be left without any financial assistance after the passing of the subscriber. Thus, the Court stressed that allowing subscribers to discontinue the policy and receive benefits during their lifetime, even upon reaching the age of 60, would undermine this objective.

The Court noted that the amendment permitted annuity or lump sum payments to disabled dependants upon the subscriber reaching 60 years of age, rather than after the subscriber's death. While this change provided greater flexibility to subscribers, the Court made it clear that the amendment was prospective, with an effective date of 1 April 2023.

The court clarified that permitting the retrospective application of the amendment would interfere with the original contractual terms under which the policies were subscribed. The Court held that the sub-stratum (or foundation) of these contracts could not be retroactively altered without undermining the contractual basis agreed at the time of subscription.

The Court further reasoned that the terms of the original policies, which specified that payments to disabled dependants would be made only after the death of the subscriber, were fundamental to the purpose of these policies. Any deviation, such as allowing the subscriber to receive benefits during their lifetime, would contradict the original objective of ensuring posthumous support for disabled dependants.

# National Conference of the District Judiciary

31 August 2024 – 1 September 2024

## Inaugural Session

The two-day “National Conference of District Judiciary”, organised by the Supreme Court of India, took place from August 31 to September 1, 2024, at Bharat Mandapam in New Delhi. Prime Minister Narendra Modi inaugurated the conference on August 31 and unveiled a stamp and coin commemorating the Supreme Court’s 75th anniversary. On 1 September 2024, Chief Justice of India, Dr D Y Chandrachud released a documentary on the Supreme Court’s 75-year history with landmark Judgments and the digital publication of Courts of India in 8 languages. Between 2016–2021, it was published and printed in 6 languages. The digital publication in 8 languages and pdfs of earlier 6 languages (all 14 languages) will be available in the “Publication

Tab” on the Supreme Court of India website. The conference, spanning two days, included five sessions covering topics such as infrastructure, human resources, inclusive courtrooms, judicial security, wellness, case management and judicial training. In celebration of the Supreme Court’s 75 years, 75 saplings from 12 indigenous varieties were planted in Delhi’s Central Ridge Reserve forest area. These saplings were dedicated to President Droupadi Murmu, after which, President Murmu unveiled the Supreme Court’s new flag and insignia, designed by the National Institute of Fashion Technology, New Delhi. The new flag features the Ashoka Chakra, the Supreme Court building, and a book representing the Constitution.

The Chief Justice of India released a “Documentary on the Supreme Court” as well as the digital publication of “Courts of India” in 8 languages.*

The session commenced with a presentation by Justice Sanjiv Khanna, providing a brief overview of the present statistics concerning the recruitment

of judges and the availability of accessible infrastructure.

Mr Krishnamurthy Mishra, Principal District Judge, Jabalpur, also gave a detailed presentation on judicial infrastructure. The session concluded with interaction on strategies to improve court infrastructure, human resource management and recruitment, along with medical facilities in courts.

The Courtrooms for All session emphasised creating inclusive spaces within the judiciary for women, marginalised communities, and persons with disabilities. The panellists included the Chief Justice of India, Dr D Y Chandrachud, Justice B V Nagarathna, Judge, Supreme Court of India, Justice Sunita Agarwal, Chief Justice of the High Court of Gujarat, and Dr Shalini Phansalkar Joshi, former Judge, High Court of Bombay.

During the session, there was a presentation on the Supreme Court’s Handbook on Combating Gender Stereotypes emphasising the importance

of avoiding stereotypical language and promoting gender-sensitive communication in courtrooms, by Ms Nivedhitha K, Legal Consultant, Supreme Court of India. Whereas Mr Anurag Bhaskar, Deputy Registrar, Centre for Research and Planning, discussed insights into the language used in judicial decisions that disproportionately affect the marginalised communities.

Meanwhile, the Chief Justice of India, Dr D Y Chandrachud and Justice Sunita Agarwal added their valuable insights as to how the judicial officers can make the courtrooms and the court premises more accessible.

The Session IV of the conference delved into the important issue of reduction of pending cases in the District Judiciary. The panel for the session included the Chief Justice of India, Dr DY Chandrachud, Justice Vikram Nath and Justice Dipankar Datta, Judges, Supreme Court of India, Chief Justice of the High Court of Patna, Justice K Vinod Chandran, and Justice Sheel Nagu, Chief Justice of the High Court of Punjab and Haryana.

Justice Datta presented the Supreme Court's 'Action Plan for Arrears Reduction in the District Judiciary (APAaR-DJ),' which involves a phased approach to address pending cases along with integration of

technological tools like the NJDG and the JustIS App.

The panellists contributed to the discussion with their views on pre-litigation strategies, mediation, bail, and the impact of the new criminal laws on the judicial sphere. The session further involved discussions on the optimisation of judicial processes and use of digital tools at the district level.

The second last session of the two-day conference involved discussion on Judicial Training which focused on the curriculum and the training methods for judicial officers. The panellists for the session included: the Chief Justice of India, Dr D Y Chandrachud, Justice Hrishikesh Roy, Judge Supreme Court of India, Chief Justice of High Court of Telangana, Justice Alok Aradhe, Chief Justice, High Court of Bombay, Justice Devendra Kumar Upadhayaya, and Chief Justice of High Court of Karnataka, Justice N V

Anjaria. The discussion emphasised on the role of mentorship in judicial careers in creating a network of continuous guidance from seniors and peer learning for mutual cooperation. Justice Hrishikesh Roy added to this by highlighting the use of films and non-conservative methods for judicial training. He praised films like *The Bridge* and *Laapataa Ladies* which could be used as effective tools for teaching and creating social awareness. He encouraged judges to adopt a positive demeanour.

Union of India, 2024 INSC 280*, the Supreme Court of India has recognised the right against climate change as an integral part of fundamental rights. This acknowledgement is a pivotal step towards balancing ecological needs,

such as the preservation of critically endangered species like the Great Indian Bustard, with the demands for renewable energy sources like solar power. This session highlighted that climate change transcends national borders, impacting migration, water scarcity, and overall environmental degradation, thus requiring a global, eco-centric approach.

### Session III on Artificial Intelligence (AI) and Legal Liability

The session delved into the complexities surrounding AI, particularly in terms of legal liability, intellectual property (IP) rights, and the implications of AI-generated content. AI's growing role in various sectors, including autonomous vehicles, medical decision-making, and online content moderation, raises significant questions about accountability and the allocation of responsibility.

The conversation further explored the challenges of AI-generated content, particularly in the realm of intellectual property. Questions were asked about whether AI can be considered an inventor or if AI-generated works can be copyrighted. The session referenced cases like the “DABUS case” in Australia, where a patent was granted to an AI, contrasting with decisions in the US and India, where AI is not recognised as a person capable of holding a patent.

## War Room

In the month of August, the Supreme Court inaugurated the Command Control Centre (CCC), popularly known as the 'War Room.' The Chronicle team interacted with Registrar, Technology, Mr Hargurvarinder S Jaggi and Mr Ashish Shiradhonkar, Registrar, Innovation and Planning, who gave some insights about 'War Room.' Mr Jaggi, explained that the idea of the 'War Room' with state-of-the-art technology was conceptualised by the Chief Justice of India, after visiting the Command and Control Centre at NIC Headquarters, Delhi, and National Data Centre in the summer of 2023.

The 'War Room' is equipped with state-of-the-art video wall, servers, computer systems, and video-conferencing equipment for monitoring critical data such as institution, listing, disposal of cases. A dedicated 'War Room' to view the data, information from multiple sources in one go, video wall which can be split into multiple screens, assisting the Judges in making informed decisions.

The Chief Justice of India, Dr D Y Chandrachud while appreciating the newly constructed War Room mentioned that:

*'We have a facility in the war room to monitor which case file is pending before which desk officer, how long that case file has been pending for processing, 0-3 days, 3-5 days, 5-7 days, so on and so forth. If the file has been pending for a longer time period, we know that the allocation of the case needs to be rationalised and we will know the exact reasons as to why it is taking a longer time to process..... The war room also helps monitor the video conferencing facility in the Court. The staff is constantly monitoring that the process runs smoothly.'*

Justice Hima Kohli retired from the Supreme Court of India on 1 September 2024. Prior to her appointment to the Supreme Court on 31 August 2021, she was the Chief Justice of the Telangana High Court, becoming the first woman to hold that position. During her tenure at the Supreme Court, Justice Kohli's time was marked by a stellar array of judgments and writings on a range of issues, including women's rights, bail matters, legal doctrines and the promotion of mediation.

A staunch supporter and dedicated advocate for women's rights, Justice Kohli also led the Gender Sensitization and Internal Complaints Committee

(GSICC) at the Supreme Court. Calling for departure from the idea limited to women development and pressing for 'women led development', Justice Kohli paved the way for these ideals from her early days as a female lawyer to her role as wisdom-clad senior judge. Her work in the judiciary and her advocacy for women's issues have left a lasting legacy and will continue to inspire future generations.

On 29th August 2024, Justice B V Nagarathna, member GSICC along with the Member Secretary, Dr Sukhda Pritam, and other members of the Committee paid their respects and gratitude to the Chairperson on the occasion of her retirement.

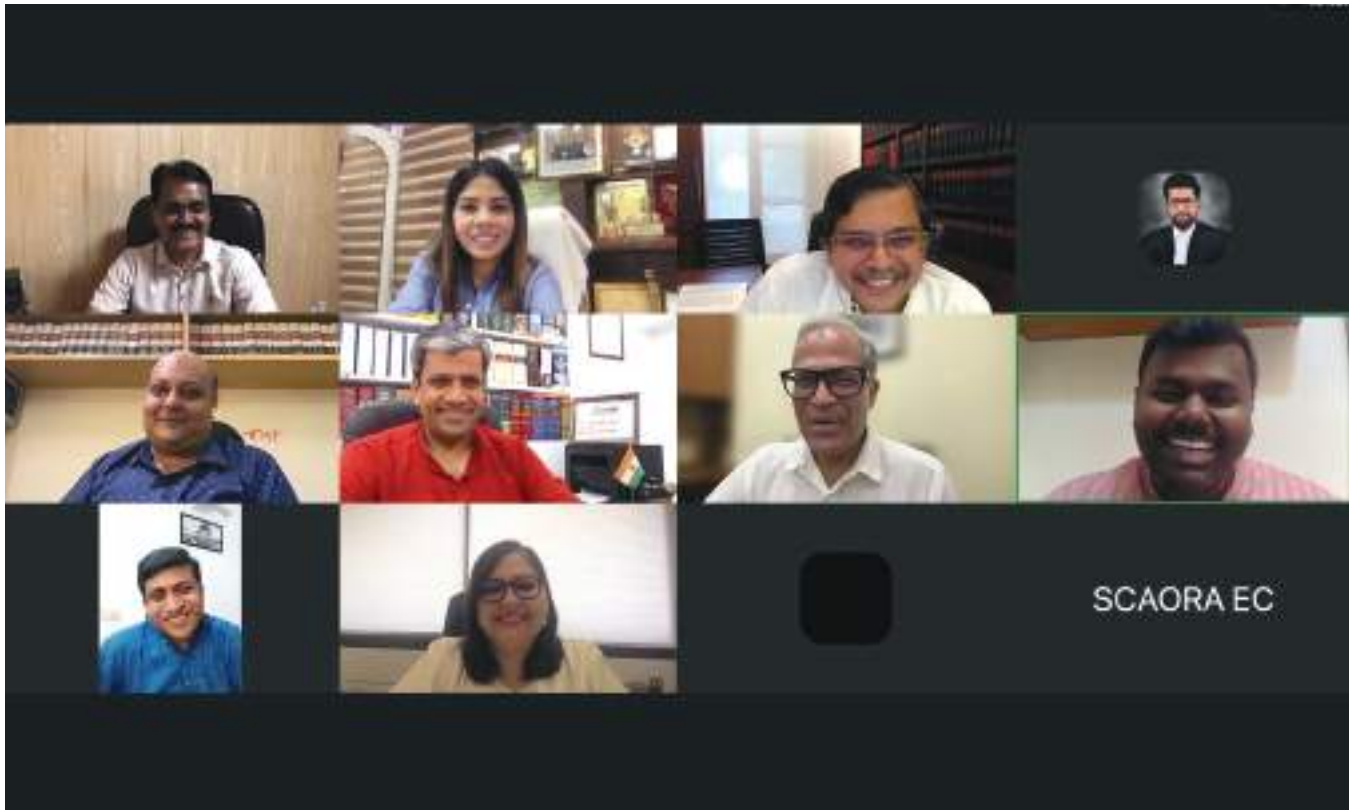
