**Method of Selection:**

Selection will be made by the Selection Committee headed by Hon'ble Prl. District & Sessions Judge and Chairman, District Legal Services Authority in accordance with National Legal Services Authority (Free and Competent Legal Services) Regulations, 2010.

**Eligibility:**

- a. The Advocates having more than 3 years experience as legal practitioner at the Bar is eligible for selection as panel lawyer.
- b. The Advocate having less than 3 years experience may also apply if he/she is extraordinarily good to work in the Legal Services Institutions.


**: General Instructions to the Applicants :**

1. The applications are made available in the office of District Legal Services Authority, District Court Complex, ADR Building, Vijayapura and in Vijayapura District Court website.
2. The applications shall be submitted on or before **02.05.2025**.
3. The application shall be accompanied with proof of professional experience issued by the Bar Association; certificate issued by the Karnataka State Bar Council and two recent pass port size photographs.

4. The applicants shall read all the instructions carefully before submitting the application.
5. The applicants shall provide Mobile number and valid e-mail ID for communication.
6. The decision of the Chairman, DLSA will be final as to the eligibility for selection.
7. The list of eligible applicants short listed for interview will be published in District Court website as well as in the office of DLSA, Vijayapura.
8. The applicants shall have appear for the interview if called for at the time and place decided and notified by DLSA.
9. Selection of Panel Advocates is fully based on their eligibility and satisfaction by the Selection Committee.
10. After the selection, if it is found that the performance of the panel lawyer is not satisfactory and if the panel lawyer acts contrary to the object and spirit of the Act and the Regulations, the Selection Committee is at liberty to take appropriate steps including removal from the panel.
11. If panel lawyer receives any fee, remuneration or any valuable consideration in any manner from the person to whom he has rendered legal services under Regulations, he/she will be disqualified and removed from the panel.
12. The panel is prepared form 3 years and also be revied and updated periodically by the Hon'ble Chairman, DLSA keeping in view the performance of th panel lawyers.
