- b. The Advocate having less than 3 years experience may also apply if he/she is extraordinarily good to work in the Legal Services Institutions.

- The decision of the Chairman, TLSC Sindagi will be final as to 6. eligibility for selection. the
- The list of eligible applicants short listed for interview will be 7. published in District Court website as well as in the office of DLSA, Vijayapura.
- The applicants shall have appear for the interview if called for 8. at the time and place decided and notified by TLSC Sindagi.
- Selection of Panel Advocates is fully based on their eligibility 9. and satisfaction by the Selection Committee.
- After the selection, if it is found that the performance of the 10. panel lawyer is not satisfactory and if the panel lawyer acts contrary to the object and spirit of the Act and the Regulations, the Selection Committee is at liberty to take appropriate steps including removal from the panel.
- If panel lawyer receives any fee, remuneration or any valuable 11. consideration in any manner from the person to whom he has rendered legal services under Regulations, he/she will be disqualified and removed from the panel.
- The panel is prepared form 3 years and also be revied and 12. updated periodically by the Hon'ble Chairman, TLSC Sindagi keeping in view the performance of the panel lawyers.
