Eligibility conditions of the post are as under:-

#### (A) LAW OFFICER GRADE-II

#### By deputation/ absorption

(a) Serving Border Security Force Officers with Graduation in Law and six year Group 'A' service with minimum three years experience in legal affairs;

OR

A law graduate in Central/State Government services (b) holding analogous post and having not less than six years experience in legal affairs;

A member of the State Judicial Service having six years (c) regular service;

(d) A commissioned officer with six years regular service and having three years experience in legal affairs in the Department of Judge Advocate General in the Armed Force of the Union;

#### OR

(e) An officer having Degree in law and experience of six years as a prosecution Counsel in the pay scale of Rs.8000-13500(pre-revised) under the Central Government or a State Government.

Note: (Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department shall ordinarily not exceed three years. The maximum age limit for appointment by deputation/ absorption shall not be exceeding 56 years as on the closing date of receipt of applications).

#### By re-employment

Retired/released officers from Army, Navy and Air Force who had held analogous post before retirement and possessing following qualifications, having break in service not more than two years :-

#### <u>Essential</u>

- Degree in law, (i)
- Six years minimum experience in legal affairs, (ii)
- Should be qualified for enrolment as an advocate. (iii)

#### Desirable

- A post graduate Degree in law (i)
- (ii) 2 years experience in dealing with trials under special laws relating to Armed Forces.

- Those officers who are in medical category SHAPE-i as specified in BSF Manual Volume IX, shall be eligible for appointment on deputation/ absorption/ re-employment. The officer so appointed will be governed by the BSF Act and Rules during the period of his deputation/ absorption/ re-employment and liable to be posted anywhere in India. They shall have to wear the uniform as specified in the Border Security Force Manual Volume- VII and the persons appointed from the civil posts or Bar shall have to complete successfully nine weeks basic training on their initial appointment in the field of law, office procedure, accounts and such other subjects as may be specified, from time to time, by the Director General, BSF.
- The other terms and conditions on deputation will be as per the provisions contained in Government of India, Ministry of Personnel Public Grievances & Pension (Deptt. Of Personnel & Training) letter No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 and as amended from time to time.
- 5. Since the post is required to be filled up urgently, it is requested that the applications of officers in the enclosed proforma along with complete up to date CR dossiers may be forwarded to the Deputy Inspector General (Pers), HQ DG BSF, Block No.10, 5<sup>th</sup> Floor, CGO Complex, Lodhi Road, New Delhi within 60 days from the date of publication in "Employment News Weekly". While forwarding the applications, it may be verified and certified that the particulars furnished by the officers are correct and that no disciplinary or vigilance case is pending/ contemplated against the officer. It may also be confirmed that in the event of policion in appointment, the officer concerned will be relieved of his auties.
