This is for the information of all concerned that the Hon'ble Supreme Court of India has launched the electronic version of the Supreme Court Report (e-SCR) as an initiative to provide digital version of the judgments of the Supreme Court as they are reported in "Supreme Court Reports", the official law report. e-SCR will facilitate access to the judgments of the Hon'ble Supreme Court, free of subscription or any other expense for the user. The database of e-SCR contains at present about 34,000 reported judgments of the Hon'ble Supreme Court. The search facility in e-SCR provides for free text search, search within search, case type and case year search, judge search, year and volume search and bench strength search option.

The access link/ tab of e-SCR is available on the Supreme Court website, the mobile application of the Supreme Court and also the judgment portal of the eCourts Project. (https://judgments.ecourts.gov.in/).
