ORDER:

The recording of the Dying Declarations have to be attended by the following Junior Civil Judges working in Guntur on monthly rotation as follows:



In case any vacancy of the post or leave of any Officer, the In-charge Officer shall attend the work of recording of Dying Declarations.

In view of the Protocol duties assigned to the I Addl. Junior Civil Judge, Guntur, the duty of recording dying declarations during the period scheduled to the I Addl. Junior Civil Judge, Guntur, the Spl. Judicial Magistrate of I Class for Excise cases, Guntur shall attend the duty of recording dying declaration in the event of protocol duty , and the I Addl. Junior Civil Judge, Guntur shall inform the intimation/information received as to the protocol duty well in advance in writing or in case of exigency communicate through mobile, to the Special Judicial Magistrate of Frist Class, Prohibition and Excise, Guntur and the Special Judicial Magistrate of First Class, Prohibition and Excise Guntur shall attend the recording of the dying declarations of the victim during that time. In case of availment of leave/permission by the Special Judicial Magistrate of

First Class, Prohibition and Excise, Guntur during the time when the I Addl. Judicial Magistrate of First class, Guntur the Officer is to attend the protocol duties, the officer placed in-charge of the Special Judicial . Magistrate of First Class , Prohibition and Excise, Guntur shall attend the dying declarations and the I Additional Judicial Magistrate of First Class, Guntur shall follow the same procedure as to intimation of the protocol duties to the concerned officer placed in charge of the Special Judicial Magistrate of First Class, Prohibition and Excise, Guntur.

The proceedings shall come into effect from July, 2022.
