The State Legal Services Authority, established under the Legal Services Authorities Act, 1987 with mandate to provide free and competent legal services to the underprivileged and disadvantaged sections of the society to ensure that opportunities for securing Justice are not denied to any citizen by reason of economic or other disabilities and to secure that the operation of the legal system promotes justice on a basis of equal opportunity to all.

Under the aegis of NALSA and State legal Services Authority the Legal Aid Defence Counsel system was established and functioning in the office of the District Legal Services Authority Guntur, the vacancy for the post of Chief Legal Aid Defence Counsel was arised due to discontinuation of previous chief Legal Aid Defence Counsel.

Applications are invited from eligible lawyers having requisite qualifications for Contractual full time engagement for the post of Chief Legal Aid Counsel, as per scheme proposed herein. The Lawyer so engaged therein will not be allowed to take any other private cases or any other retainership.

The duly filled application form along with self- attested copies of documents may be submitted to DLSA, the interested candidates shall submit their applications through speed post or in an envelope personally to the Chairman, DLSA -cum-Prl. District Judge, District Court Complex, Nagarampalem, Guntur on or before 15-04-2024 by 17.00 Hrs. Any application received after due date shall not be considered.

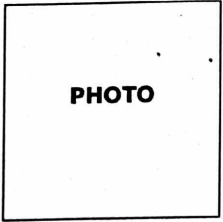
