Permission for availment of these option holidays should be however, be applied for in writing in advance and will normally be granted by the officer competent to grant Casual leave with due regard to exigencies of the Court work which should not be affected in any way what so ever. This leave for two days taken by Government Employees at their option on the festival of their choice will not be debited to their casual leave account.
