**ORDER**

In view of the recent surge of Covid-19 cases, and, in order to ensure that preventive measures are being adopted by everybody concerned within the premises of this establishment, to stem the spread of the viral infection, the following guidelines are to be strictly followed by all the concerned, viz. judicial officers, staffs, advocates and general public visiting the court premises :-

1. Overcrowding in the courts and offices must be avoided. Social distancing of minimum 6 (Six) Feet is to be maintained by all persons within the court premises.
2. Wearing of Face Mask within the court premises is mandatory.
3. The staffs, judicial officers, advocates, and general public visiting the court premises, should frequently resort to using hand sanitizers to prevent the spread of Covid-19 disease.
4. Learned Advocates are requested to ensure that only those litigants/ parties whose appearance is necessary, be called to the court premises to attend court proceedings to prevent unnecessary congestion/ overcrowding inside the courts.
5. Cooperation from the Members of the Bar Association, in view of the above, would be highly appreciated. Learned advocates visiting/attending the Bar rooms are requested to adhere to COVID-19 protocols issued by the Hon'ble Gauhati High Court/ Government from time to time.

The above instructions is to be followed strictly, with immediate effect.


