
The tender must reach the office of the undersigned **on or before 01:00 PM of 15.12.2022** and the tenders shall be opened in presence of the members of the Committee.

DETAILS OF REQUIRED VEHICLE



TERMS AND CONDITIONS:

1. The cost price of the vehicle should not exceed Rs. 15 Lakhs.
2. The vehicle to be outsourced should be registered as a **commercial vehicle under Registering Authority of Govt. of Assam.**
3. The party is required to be **handed over the vehicle positively within 3 (three) weeks from the date of issuance of the Work Order** in that regard.
4. All maintenance of the vehicle shall be done by the outsourcing parties/agencies/firms/individuals **(except driver & fuel).**

5. **No driver is required from the end of the tenderer.**
6. The contract period will be initially for 1 (one) year which may be extended (if necessary) or till new vehicle is provided by the Government.
7. The vehicle should be made available 24X7 in the service of the undersigned.
8. The vehicle should be comprehensively insured and should carry all necessary permits; clearance from the Transport authority or any other concerned authority, pollution certificate, fitness certificate etc. from the competent authority. **Undertaking in this regard is required to be submitted by the tenderer along with the tender.**
9. The interested parties/agencies/firms/individuals must submit the sealed quotation containing tender along with self attested copies of their GST Registration Certificate, PAN Card along with other relevant documents, if any, as mentioned in the notice.
10. The sealed envelope containing quotation shall be marked as "**Quotation for Outsourcing Vehicle for Special Judge, CBI & NIA, Assam, Chandmari, Guwahati-3**".
11. The undersigned reserves the right to accept or reject any or all the tenders in part or full, without assigning any reason whatsoever.
