

Applications are invited from intending eligible candidates, in the prescribed Standard Form, for filling up the following Grade-IV (Peon) vacant posts in the Establishment of the Principal Judge, Family Court-I, Kamrup, Guwahati.

Sl. No.	No. of vacant post & category	Scale of Pay	Requisite Qualification
1.	Grade-IV (Peon) Unreserved Category	(PB-I) Rs.12,000 – 52,000 +Grade Pay Rs.3,900/- + other allowance as admissible.	The candidate must possess the minimum educational qualification of Class-VIII Standard passed. Those who have appeared in HSSLC or equivalent or above examination need not apply. They will be treated as ineligible. Applicants have to produce a self-declaration certificate along with the application form mentioning that "he/she has not appeared HSSLC or equivalent examination or above examination".

Eligibility criteria: -

- 1) The candidate must be an Indian Citizen.
- 2) The candidate must not be less than **18 years** and more than **40 years** of age as on 01.01.2023. The upper age limit will be relaxed by:-
 - (i) By 5 years for ST and SC candidates i.e. up to 45 years as per Govt. Notification No.ABP.6/2016/51, dated 02-09-2020 issued by Department of Personnel, Government of Assam,
 - (ii) By 3 years for OBC / MOBC candidates i.e. up to 43 years as per Govt. Notification No.ABP.6/2016/51, dated 02-09-2020 issued by Department of Personnel, Government of Assam.

HOW TO APPLY /SELECTION PROCEDURE :-

1) Eligible candidates will have to apply in Standard Form of Application (published in the Gazette Part IX of Govt. of Assam) and must submit to "The Principal Judge, Family Court-I, Kamrup (M), NEJOTI Building, B.K. Kakoti Road, Ulubari, Guwahati-781007, Assam". **The Last date of receipt of application is 30-03-2023 till 4.00 PM. To the Office of the Principal Judge, Family Court-I, Kamrup (M), NEJOTI Building, B.K. Kakoti Road, Ulubari, Guwahati-781007, Assam either by post or directly in the drop box which will be closed thereafter.** The Selection Board shall not be responsible under any circumstances for any postal delay.

2) The application must be accompanied with the following:-

- (a) Three recent coloured-passport size photograph with signature on the reverse side,
- (b) Self-attested copies of testimonials in support of his/her AGE, CASTE, EDUCATIONAL QUALIFICATION etc.
- (c) Self declaration certificate.
- (d) Mobile Nos. must be written on the top of the Standard Form in RED INK.
- (e) Valid Employment Exchange Certificate (mandatory).

3) Candidates already in Govt. service must apply through proper channel and shall have to produce 'No objection Certificate' from the employer on the date of interview, if shortlisted for interview.

4) Incomplete or late received applications will summarily be rejected.

5) If any candidate found canvassing directly/indirectly his/her candidature will be rejected.

6) The applications can be submitted through Ordinary/Speed/Registered Post or by directly to the office of the undersigned. After preliminary scrutiny of applications, the provisionally eligible candidates have to appear in written Interview/Viva Voce at their own expense and no TA. & D.A. is admissible in this respect. The application should be submitted in a sealed envelope with the heading properly mentioned as "Application for the post of Grade-IV(Peon)". The selection will be made purely on merit basis. No individual call letters will be issued to the candidates. However, the list of sorted-out candidates and Date and Place of Interview will be uploaded in the
