


ADVERTISEMENT

Applications are invited from intending eligible candidates in prescribed Standard Form, for filling up the following Grade-IV vacant post in the Establishment of the Industrial tribunal, Guwahati within 15 days of publication of this advertisement.

Terms and conditions:

1. The candidates must be citizens of India as defined under Articles 5 and 6 of the Constitution of India and must not be less than 18 years and more than 40 years of age as on 01.03.2023
2. Candidates must submit their applications in the standard format along with self attested copies of all testimonials regarding educational qualification and age. The candidates shall paste his/her recent passport size photograph in given space of the application. 2 (two) more copies of passport size photographs, duly signed by the candidates on the back side shall staple on the top right corner of the application form.

The application shall be addressed to : The Presiding Officer, office of the Industrial Tribunal, Guwahati Deputy Commissioner, Kamrup (Metro) Office Building, 3rd Floor, Hengrabari, Dispur, Guwahati – 36, (Assam), and may be sent by post. The candidates may also submit their applications by hand directly in the drop box kept in the office of Industrial Tribunal, Guwahati from 10.00 A.M. to 5.00 P.M. on the working days.
4. The candidates shall have to mention their mobile numbers with whatsapp in their applications. The applications of the candidates who have passed class XII and above shall be summarily rejected.
5. Candidates who are already in Govt. Service must apply through proper channel and shall have to produce 'No Objection Certificate' from the employer on the date of interview, if shortlisted for interview.
6. After preliminary scrutiny of application, the eligible candidates whose applications are accepted shall be called for interview/Viva voce in due course.
7. Date and place of interview and list of eligible candidates will be notified in due course in the official website of (<https://kamrupmetro.dcourts.gov.in>). No separate call letters will be issued to the candidates for the interview/viva voce. Hence candidates are advised to visit the said website regularly. No TA/DA shall be admissible for appearing in the interview.
