As per Section 2(t) of The Persons With Disabilities(Equal Opportunities, Protection of rights and Full Participation) Act, 1995, only such persons are eligible for reservation in PWD category, who suffer from minimum **40 percent** of relevant disability. The upper age limit for recruitment of PWD candidate shall be as per the State Government Rules and the PWD candidates shall have to submit a Disability Certificate issued by a competent authority in the format given herewith at **Annexure-I**.

## 3. SELECTION PROCESS:

The selection process will be held in one phase, i.e. through Interview/Viva-Voce .

## 4. TERMS AND CONDITIONS:

- i. Candidates must submit relevant testimonial/certificate and 4(four) recent passport sized photographs along with the application. However, candidates have to produce their **original** testimonials regarding educational qualifications, date of birth, caste, working experience etc. at subsequent stages when asked for.
- ii. In appropriate cases, relaxation of age will be admissible as per the existing rules of the Government of Assam.
- iii. One self- addressed envelope of 5cm x 11cm affixing postal stamp of Rs. 5/- (Five) is to be enclosed with the application along with a **valid mobile number**, if any.
- iv. The date, time and venue of the interview/viva-voce will be notified in due time which will be published in the Notice Board and Official Website of this office. The candidates are advised to keep checking the website of Kamrup(M) District Judiciary.
- v. The list of provisional candidates with allotted Roll Numbers will be published in the official website of Kamrup(M) District Judiciary <https://kamrupmetro.dcourts.gov.in> , for the candidates' reference.
- vi. No TA/DA shall be paid to the candidates for appearing in the Interview/Viva-voce.
- vii. Candidates who are already in Government Service (Central/ State or PSU) may apply through proper channel. They shall have to produce "No Objection Certificate" from the present employer at the time of document verification before the Interview/Viva-voce and they will have to submit release order at the time of joining.
- viii. Application form which is incomplete in any respect, such as, without photograph and signature, is liable to be rejected summarily.
