A meeting of the Monitoring Committee was convened at the above mentioned venue at 4:00 p.m. on 06.03.2023 under the chairmanship of the District & Sessions Judge, Kamrup(M) and in presence of the Members as mentioned above.

After discussion, the Committee has taken the following Resolutions:-

Resolution No.1

The DCP s have apprised that appropriate action has been taken in terms of negligence of duty on the part of the police personnel in respect of A.B. Case No.

02/2023, which was discussed in the previous meeting. The District & Sessions Judge, Kamrup(M) has asked to inform the concerned Court accordingly.

Resolution No.2

The Addl. Sessions Judge –cum- Special Judge, POCSO, Kamrup(M) has specifically mentioned about two cases, where inspite of sending several reminders, the medical reports are not submitted. It was informed that in Basishtha P.S. Case No. 762/17, the medical examination report and the charge sheet are not submitted till date whereas the case was registered on 29.08.2017 and the accused is in Jail Hajot.

In respect of Fatasil Ambari P.S. Case No. 388/2018, the charge sheet is not submitted till date and it is reported that the case diary has been missing. The Addl. Sessions Judge –cum- Special Judge, POCSO has requested to ensure that the proceedings be initiated on the basis of the duplicate case diary.

Resolution No.3

The Chief Judicial Magistrate, Kamrup(M) has submitted a list of 30 cases of various police stations where the Under Trail Prisoners are in the Jail beyond the statutory period and has requested the DCP s to look into the matter and take appropriate action accordingly. It hs been discussed that necessary directions may be issued to the concerned I.O to send the reports in Final Form, either in charge sheet or Final Report

Further the Chief Judicial Magistrate, Kamrup(M) has mentioned that the list of cases would be provided to the CID for ensuring that steps may be taken for procuring the attendance of the witnesses.

Resolution No.4

Another matter was discussed in respect of collection of disposal data from the Courts. The Prosecuting Inspector, Kamrup(M) was informed to do the needful to collect the disposal data from the concerned Courts.

Resolution No.5

The District & Sessions Judge, Kamrup(M) has discussed that it is noticed in the reports submitted by the I.O s regarding submission of case diaries before the Courts which are called in connection with bail applications, the I.O s usually mention that the charge sheets have been submitted whereas on enquiry it is found that the same is yet to be submitted physically. The DCP s have been requested to look in to the matter.




