Pursuant to Resolution dated 30.03.2023 of the Selection Board of the establishment of Special Judge, CBI, Assam, Guwahati and in the interest of public service, **SH. PRADIP BHAKAT**, son of Sukdeb Bhakat, permanent resident of House No.287, village-Rangafali, PO-Naherbari, PS-Ghograpar, Nalbari, Assam, Pin-781349, is appointed temporarily in the vacant post of Peon (Grade IV), sanctioned vide No.FTX.93/69/14 dated 13.06.1969 in the Revised Pay Scale in PB-1 of Rs.12,000/- to Rs.52,000/- with Grade Pay of Rs.3,900/- plus other allowances as admissible under the Rules.

The appointment will have to subject an undertaking to that effect at the time of joining the said post.
