After discussion, the Committee has taken the following Resolutions:-

### **Resolution No.1**

The District & Sessions Judge, Kamrup(M) has mentioned about a specific case, Sessions Case 175/2017, a case relating to one of the sitting M.L.A s, where the witness name Shri. Jagar Singh, Inspector of Police, CID, Assam, has not appeared in the Court inspite of the summon being served. The S.P, CID is requested to do the needful to inform the concerned Inspector as the next date fixed is 08.06.2023.

#### **Resolution No.2**

The DCP s have mentioned that the police personnel find it difficult to serve summons to the Medical Officers, specially on holidays. The Deputy Superintendent of GMCH is requested to discuss the matter with the Superintendent of GMCH, so that the one specific Officer may be entrusted to collect the summons on holidays etc.

# **Resolution No.3**

The District & Sessions Judge, Kamrup(M) has discussed that in respect of one NDPS case, the seizure list is not signed by the I.O. The DCP s are requested to inform the I.O s to be extra careful in such matters.

## **Resolution No.4**

It was also discussed that in some cases under Section 326, the injury report is found to be missing, which causes difficulties while dealing with the bail matters. The DCP s have assured to look into the matter.

#### **Resolution No.5**

The Additional Chief Judicial Magistrate, Kamrup(M) has mentioned that the case diaries are not found in five nos. of cases. The list of those cases would be provided to the DCP for doing the needful at their end. The DCP s are also requested to produce the duplicate case diaries in terms of those cases.
