**Eligibility**

- **Qualification** : Minimum Class – VIII standard and those who have passed HSSLC or above shall be ineligible to apply. Applicants have to produce a self declaration certificate along with the application form mentioning as follows:  
“I have not passed HSSLC or equivalent examination and I shall be liable for criminal prosecution for false detection of my educational qualification.”
- **Age limit** : Minimum 18 years and maximum 40 years as on 01.01.2023.

- 6) Age relaxation will be as per Govt. norms for reserved categories.
- 7) Candidate already in service should have to apply through proper channel.
