Terms and Conditions:

1. The Vehicle should not be preferably more than 1 year old and the total running should be preferably less than 20,000 kms.
2. All maintenance of the vehicle shall be done by the outsourcing parties/agencies/firms/individuals (except driver & fuel).
3. No driver is required from the end of the tender.
4. The contract period will be initially for 1 year(one) which may be extended (if necessary) or till new vehicle is provided by the Government.

5. The vehicle should be comprehensively insured and should carry all necessary permits, clearance from the Transport authority or any other concerned authority, pollution certificate, fitness certificate etc. from the competent authority.

Undertaking in this regard is required to be submitted by the tenderer alongwith the tender.

6. The vehicle should be made available 24X7 in the service of the undersigned.
7. The interested parties/agencies/firms/individuals must submit the sealed quotation containing tender alongwith self attested copies of their GST registration certificate, PAN card, Vehicle registration Card, Vehicle Insurance Certificate alongwith other documents as mentioned in the notice.
