## 2. ELIGIBILITY CRITERIA:

Driver	Candidates shall have to pass Class VIII .Apart from that
	the candidate must possess a valid Driving License.

## 3. SELECTION PROCESS:

The selection process will be held in two stages. The first stage would be Driving/Screening Test and the second stage would be the Interview/Viva-voce. Those candidate who would qualify the Driving/Screening Test, will be called for Interview/Viva-voce. On the basis of the sum total of marks obtained in driving test and viva-voce, the final select list will be prepared.

The Driving/Screening Test will be conducted for 50 marks and the qualifying marks will be 30 marks, i.e. in order to qualify the Driving Test, a candidate has to secure 30 marks and above. The Interview/Viva-Voce will be conducted for 40 marks.

## 4. TERMS AND CONDITIONS:

- i. Candidates must submit relevant testimonial/certificate and 4(four) recent passport sized photographs along with the application. However, candidates have to produce their **original** testimonials regarding educational qualifications, date of birth, caste, working experience etc. at subsequent stages when asked for.
