ELIGIBILITY :-

- 1) Candidates must be Indian Citizens as defined in Article 5 to 8 of the Constitution of India.
- 2) Candidates must have registered their names in the Employment Exchange and the registration must be valid on the date of application.
- 3) Candidates must not be less than 18 years and more than 40 years of age on the date of publication of the advertisement. The upper age is relaxable as per govt. rules.
- 4) Minimum educational qualification of the candidates is class-VIII (Eight) and maximum is HSLC passed. Over-qualified candidates will be rejected.

Intending candidates shall submit their applications in Standard Form (published in Part-IX of the Assam Gazette) addressed to "***The Member, Motor Accident Claims Tribunal, No.3, Kamrup (M), Bharalumukh, Guwahati-9***" either

through person or through Speed Post. The Applications must be accompanied with –

- (1) Two recent coloured Passport size photographs with their name(s) written on the reverse side.
- (2) Self-attested testimonials in support of their educational qualification , experience (if any) and caste.
- (3) Self-attested certificate(s) of other qualification or skill, if any.
- (4) Copy of valid Employment Exchange Registration Card.
- (5) Candidates serving in Govt. Department must submit their applications through proper channel alongwith copy of NOC, Service Book & 3 (Three) years' ACR.
- (6) The candidates must write their mobile number(s) on the top of the Standard Form with red ink.
- (7) The candidates must write **"APPLICATION FOR THE POST OF PEON"** in bold letters on the top of the envelope.

SELECTION PROCEDURE :-

- i) The intending candidates will have to appear in an Interview (Viva-Voce).
- ii) The selection will be made purely on merit basis.
- iii) The selection will be made in accordance with the rules of the "The Assam District & Sessions Judges Establishment (Ministerial) Service Rules, 1987".





- c) No separate call letters will be issued individually. The eligible candidates are requested to visit the official website regularly for further updates.
