## Legal STerms and Conditions:

1. Candidate must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.

A candidate shall not be below 18 years of age and above 40 years in case of general candidates as on 31.07.2024. The upper age limit in case of candidates belonging to SC & ST category shall be 45 years and in case of candidates belonging to OBC/MOBC category shall be 43 years as on 30.07.2024. (As per Govt, of Assam, Deptt. Of Personnel O.M No. ABP.6/2016/51 dated 02/09/2020)

- 3. Candidates having work experience in the field of legal aid related matters shall be given preference.
- 4. The appointments shall be purely temporary and on contract basis and doesn't entitle the person to be regularized in Govt. Service.
- 5. After expiry of the contract period of 01 year, the contractual agreement automatically stands terminated unless renewed by competent authority.
- 6. The service may be extended after appropriate break in service, subject to the approval of the Hon'ble Executive Chairman, Assam State Legal Services Authority, Guwahati.
- 7. The selected candidates shall be required to perform all the duties as mentioned in the LADCs (Modified) Scheme, 2022 in the Kamrup (M) district.
