Applications are invited from intending eligible candidates who are citizens of India as defined in Article 5 and 6 of the Constitution of India, in the prescribed Standard Form under Assam Gazette of part - IX for filling up of vacant post (highlighted here under in the table) in the establishment of Industrial Tribunal, Guwahati with pay structure plus other allowances as admissible under the rules.

TERMS & CONDITIONS FOR APPLICATION:

1. The candidate must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. The age of the candidate must not be less than 21 years of age and more than 40 years of age as on 01.01.2025. The upper age limit relaxation is 5 years for SC/ST candidates; 3 years for OBC/MOBC candidates.
3. Preference will be given to the candidates having working experience in any district Court/Tribunal of Assam.
4. The candidate who has no relevant qualification & experience need not apply.

Mode of Selection:

1. Eligible candidates will have to appear in
 - (i) Skill Test (Both English & Assamese Typing) – 50 Marks
 - (ii) Viva-voce - 50 marks.
 Candidate securing highest mark in total out of 100 marks will be selected.

1. The eligible candidates must submit their applications in the Standard Form published in Assam Gazette Part-IX only in offline mode.
2. The application must be accompanied with the following document:


- c) Valid Employment Exchange Registration Certificate.
d) Certificate of Post Graduate Diploma in Computer Application or equivalent degree.
e) At least one year Experience Certificate in the relevant field.
3. Applicants will have to produce all the testimonials in original, in the event of being selected for interview failing which his/her candidature will be rejected.
