
TERMS AND CONDITIONS:

- ii. Age will be minimum 18 years and maximum will be as per Govt. of Assam Notification. Age will be counted as on 01-01-2026.
- iii. Application are to be submitted in the drop box within the office working hours in Court office or by post {Address: Office of the Presiding officer, Labour Court, Guwahati, Hengrabari, Deputy-Commissioner's building, 3rd floor, Pin-781036}.
- iv. The envelope containing the application should be superscribed- "Application for the post of **Peon**".
- v. No application fee will be necessary.
- vi. Application form which is incomplete in any respect, such as, without photograph, signature etc., is liable to be rejected summarily without giving any information to the applicants.
- vii. Candidates who are already in Government Service (Central/State of PSU) may apply through proper channel. They shall have to produce "No Objection Certificate" from the present employer along with the application form.
- viii. Candidates shall submit a self declaration regarding their educational qualification stating that **"I have not passed HSSLC or equivalent examination and I shall be liable for criminal prosecution for submission/detection of my false educational qualification."**
