It is hereby informed for general information that the **District Legal Services Authority, Kamrup (Metro), Guwahati** intends to induct **29 (twenty-nine) Para-Legal Volunteers (PLVs)** for Kamrup (Metro) District. Accordingly, applications are invited from intending candidates residing in Kamrup (Metro) District from the following categories:

1. Teachers, (including retired teachers);
2. Retired Government Servants and Senior Citizens;
3. M.S.W. Students;
4. Anganwadi Workers;
5. Doctors/Physicians;
6. Law Students (until their enrolment as Advocates);
7. Members of Non-Political, Service-Oriented NGOs and Clubs;
8. Members of Women Neighbourhood Groups, Maitri Sanghams and other Self-Help Groups; and
9. Any other persons having an inclination towards social work.

The applicant must be a resident of Kamrup (Metro) District and shall have either permanent residence or a valid correspondence address within Kamrup (Metro) District.

The candidate should possess a **minimum qualification of Matriculation** and should have the capacity for overall comprehension. The candidate should not look upon the income derived from services as a PLV as the primary source of livelihood and should have a mindset to assist the needy and marginalized sections of society, coupled with compassion, empathy and concern for their welfare.

It is hereby clarified that the engagement of PLVs **does not carry any salary, remuneration or wages**, except the honorarium as fixed by the **Assam State Legal Services Authority (ASLSA)** from time to time. The duties, functions, terms and conditions of engagement and honorarium of PLVs shall be governed by the **NALSA Scheme for Para-Legal Volunteers** and the applicable rules, guidelines and regulations issued from time to time.

The list of eligible applicants called for interview/selection shall be notified on the **Notice Board of the District Legal Services Authority, Kamrup (Metro)** and shall also be uploaded on the official website of the District Judiciary, Kamrup (Metro), i.e. **kamrupmetro.dcourts.gov.in**.

Applications shall be received through online mode at the official e-mail ID of DLSA, Kamrup (Metro), as well as physically through post or by direct submission at the office of the District Legal Services Authority, Kamrup (Metro), up to **5:00 P.M. on or before 15 (fifteen) days from the date of publication of this advertisement.**

Applications received after the prescribed date and time shall not be entertained.

The applicants shall furnish all necessary particulars and supporting documents along with the application. Mere submission of an application shall not confer any right upon the applicant for selection or engagement as a PLV.
