**ORDER**

The Judicial Magistrates functioning in the Magistracy of this District are hereby directed to scrupulously comply with the following directions issued by the Hon'ble Supreme Court of India in its order dated **31-01-2023** passed in case no. **SMWP (Criminal) 04 of 2021 [IN RE POLICY STRATEGY FOR GRANT OF BAIL]** (*Copy enclosed*) with respect to the accused persons languishing in Prisons who are **“Bailed out but not Released”**:

**“1. The Court which grants bail to an undertrial prisoner/convict would be required to send a soft copy of the bail order by e-mail to the prisoner through the Jail Superintendent on the same day or the next day. The Jail Superintendent would be required to enter the date of grant of bail in the e-prisons software [or any other software which is being used by the Prison Department].**

**5. In cases where the undertrial or convict requests that he can furnish bail bond or sureties once released, then in an appropriate case, the Court may consider granting temporary bail for a specified period to the accused so that he can furnish bail bond or sureties.**

**6. If the bail bonds are not furnished within one month from the date of grant of bail, the concerned Court may *suo moto* take up the case and consider whether the conditions of bail require modification/relaxation.”**

The Judicial Magistrates are hereby further directed to follow the resolution taken w.r.t. agenda item no. 3 of the Notes of Discussions of the Virtual Meeting of the Member Secretary, TSLSA on 04-08-2023 held in compliance of the **order dated 25-07-2023** (*copy enclosed*) passed by the Hon'ble High Court of Tripura in case no. **WP(C)(PIL) 12 of 2022 (Court on its own motion vs. State of Tripura)** on the same subject matter.
