Tenderer may remain present during opening of tender at the office of the undersigned at specified/notified time and date. **NATURE OF WORK**

The vehicle will be used for the official use of the Judge, Family Court, Belonia, South Tripura. All maintenance cost of the vehicle including driver's salary, cost of fuel, etc will be borne by the owner/Agency of the vehicle, as the case may be.

**Terms and condition for hiring Light Motor Vehicle**

1. The Tender should be submitted in sealed cover addressed to the Judge, Family Court, Belonia, South Tripura on or before 12-09-2022 (3 pm). Tender received after the last date and time will not be entertained.
2. The vehicle should have a valid commercial registration and in good condition in all respect.
3. The detention charge and Per kilometer run charge should be within the limit/ceiling as per Annexure -1 of the DFPRT, 2019.
3. The vehicle should have up to date Insurance Policy, Pollution Control certificate and up to date Tax clearance/Tax token and other relevant papers. The vehicle be provided along with a driver having valid commercial Driving license and the salary of the driver should be paid by the owner of the vehicle. The concerned driver should maintain a Log Book.
4. The vehicle shall be maintained properly and it will be kept in up to date condition for long journey also at owner's expense.

5. Hiring vehicle will be terminated at any point of time by the office, if service provided by the owner is not satisfactory. The decision taken by the authority in this regard shall be final and conclusive.

6. The successful bidder will be liable for any loss, breakage etc of the vehicle including duty hours and the owner /agency will be under obligation to make alternative arrangement in case of providing vehicle is out of order. The alternative vehicle should have valid documents including valid commercial registration.

7. No Claim for advance payment will be entertained. Payment will be made on submission of bill in triplicate along with copy of relevant log book and the payment of bill is subject to the provisions of the Tripura VAT Act/ Income Tax Act as applicable.

8. The undersigned also reserves the right to cancel the agreement at any time, if any Government owned enmarked vehicle is provided for use in the office of the Judge, Family court , Belonia earlier than the expiry of the agreement/period of hiring of vehicle.

9. Both the Technical Bid (Annexure-I) & Financial Bid (Annexure-II) should be submitted along with tender.
