As communicated by Shri A. Ramesh Babu, Member (Project Management), eCommittee, Supreme Court of India via email dated 25<sup>th</sup> July, 2022, the OTP (One Time Password) generated by the Virtual Court (<https://vcourts.gov.in>) and ePay Portal (<https://pay.ecourts.gov.in>) have been increased from 4 digits to 6 digits following security guidelines.

Due to this security update, if any user faces OTP validation errors in the above mentioned portals, then the same may be overcome by clearing the browser history or using the browser in incognito mode.
