NOTIFICATION

In exercise of the powers conferred by Paragraph 28(3) of The Tripura (Courts) Order, 1950 and all other enabling provisions in this behalf on the subject, the Hon'ble the Chief Justice of the High Court of Tripura is pleased to make the following Rule to amend the Tripura District Courts' Ministerial Establishment (Recruitment and Conditions of Service) Rules, 2014 namely

1. Short title, extent and commencement-

- (i) This Rules may be called the "Tripura District Courts' Ministerial Establishment (Recruitment and Conditions of Service) (Amendment) Rules, 2020"
- (ii) It shall come into force with immediate effect.

2. Amendment of Schedule A

In Schedule-A of the "Tripura District Courts' Ministerial Establishment (Recruitment and Conditions of Service) Rules, 2014", the bracket and the words "(Group-B Gazetted)" shall be inserted appearing in Column 2 against Serial No.2,3 & 4 as follows:
