## **ELIGIBILITY CRITERIA:**

The candidates applying for the aforesaid post of Driver should fulfill the following eligibility criteria

- 1 That the candidates should belong to District Leh only
- That the candidates should possess the Resident Certificate of UT of Ladakh in terms of Order No 18-LA (LD) of 2021 dated 08 10 2021
- 111 That the age of candidates as on 01 01 2022 should be
  - a) Not below 18 years, and
  - b) Not above 40 in the case for General category,
  - c) 43 years in case of SC/ST/RBA/ALC/OBC.



- d) 48 years in case of Ex Servicemen,
- e) 40 years in case of candidates in Government Service/Contractual employees,
- That the candidates are in possession of the prescribed minimum qualification is 10th/matric from a recognized School Board and must possess a valid driving license with LMV/HMV endorsement by or before the last date of submission of application forms i.e., 01.10.2022.
  - v That the candidates should have deposited (non-refundable) fee of Rs 300/-(Rupees Three hundred only) through Demand Draft from J&K Bank in the name of Principal District & Sessions Judge, Leh
  - That the candidates who are already engaged on adhoc or daily wage basis in the Subordinate Courts shall be eligible to apply irrespective of the minimum and maximum standards of age, and they shall deemed to be given relaxation in the minimum and maximum standards of age

No claim of being unaware of the dates/schedule for written test/skill test (driving test), shall be entertained
- h) The in-service candidates / contractual employees shall submit the photocopy of the filled up offline application form through proper channel viz, the concerned Head of Department In the event of failure of the candidate to route the application through proper channel, his /her eligibility shall be assessed as if he/she is not an in-service candidate. The Head of Department concerned shall forward the application form of the in-service candidates at the address of the Principal District & Sessions Court Leh within the above referred period after filing their Application Form
- i) The last date for the submission of offline application forms as prescribed above shall be the cut-off date for determining the eligibility to apply for the post.
