3. The appointee shall furnish an undertaking at the time of his joining in the shape of an affidavit duly attested by Magistrate First Class to the effect that if any adverse report about his character, antecedents and the testimonials is received, in that event his appointment shall be deemed to be cancelled ab-initio and shall have no claim on his appointment.
4. The salary of the appointee is directed not to be drawn unless a satisfactory report in respect of (2) above is received.
