

**SHORT TERM TENDER QUOTATION**

In view of the Order of the Prl. City Civil & Sessions Judge, Bengaluru City dated 30.01.2023, it is hereby notified that, the interested Parties/Vendors/Suppliers may furnish their quotation for carrying out repair/replacement of Network Components of the CCTV Surveillance System and its accessories in conformity with the specifications as mentioned below for the use of the City Civil Court at Bengaluru, so as to reach the undersigned in a sealed cover **super scribed** as **"Quotation for repair/replacement of Network Components of the CCTV Surveillance System"** for the financial year 2022-2023 addressed to **"The Registrar, City Civil Court, Bengaluru"** on or before **09.02.2023 by 5.00 p.m.** and the sealed quotation will be opened on **10.02.2023 at 5-30 p.m.** before the undersigned. The description of work pertaining to the CCTV Surveillance System are as follows:



- 1) The prices quoted should be inclusive of taxes as applicable to the Government Department on the date of notification with free delivery at the Courts of the Bengaluru City.

- 2) The rates quoted for the Network Components & its accessories of CCTV equipments to be supplied in the Tender/Quotations submitted by the successful supplier for the tender will be applicable for the Financial Year 2022-23.
- 3) The quantity mentioned is tentative one and the same is subject to variation depending on the cost of the articles.
- 4) Good quality devices should be utilized strictly in conformity with the specifications detailed above.
- 5) Defective devices not in conformity with the specification as well as the additions and alterations, if any, suggested in the sample supply, are liable to be rejected.
- 6) Network Components and its accessories of the CCTV Surveillance System should contain the fixed period of **warranty not less than TWO years** towards manufacturing defects and the defective articles either to be replaced or rectified at the cost of the supplier during the period of warranty.
- 7) The intending Vendors/Suppliers shall deposit an E.M.D. of Rs.10,000.00 by way of Demand Draft drawn in the name of the Registrar, City Civil Court, Bengaluru.
- 8) The E.M.D. will be returned to the unsuccessful Tenderer immediately by way of the same DD and the E.M.D. of the successful Tenderer will be refunded on satisfactory repair/replacement of the Network Components of the CCTV System.
- 9) The payment will be made within 15 days after completion and commissioning of the CCTV equipments in good condition and the final bill will be submitted along with letter of warranty for arranging payment.
- 10) The acceptance or rejection of the quotation is at the discretion of the Prl. City Civil and Sessions Judge, Bengaluru and it is final and binding on the parties.
- 11) Network Components supplied/utilized are subject to examination by the persons of the choice of the quotation Inviting Authority to ascertain the quality of the device supplied for carrying out works for the servicing/repair of the CCTV System. The quotation Inviting Authority has right to reject any articles.
- 12) The other terms and conditions for supply of devices will be as Standard Equipments.
- 13) The quotation received after the due date and also without the earnest money deposit by way of DD will not be entertained at any circumstances and those quotations are deemed to be rejected.
- 14) Any clarification with regard to technical specifications for the CCTV equipments to be supplied/utilized for making the Network Components and accessories serviceable the supplier/vendor is to contact Software Technician, Computer Branch, City Civil Court, Bengaluru.
