On **09.12.2023** Karnataka State Legal Services Authority, Bengaluru has organized National Lok Adalat in the entire State of Karnataka. It is a golden opportunity to the general public to seek redressal of their pre-litigation and pending cases before the Courts of Law.

The following cases may be settled before the Lok Adalat:

<b><u>Pre-litigation</u></b>	<b><u>Pending in the Courts</u></b>
(i) NI Act cases under Section 138;	(i) Criminal Compoundable Offence
(ii) Bank Recovery cases;	(ii) NI Act cases under Section 138;
(iii) Labour disputes cases;	(iii) Bank Recovery suits;
(iv) Electricity and Water Bills (excluding non-compoundable)	(iv) MACT cases;
(v) Others (Criminal Compoundable, Matrimonial and other Civil disputes, please specify)	(v) Labour dispute cases;
(vi) Real Estate Regulatory Authority Cases	(vi) Electricity and Water Bills (excluding non- compoundable);
(vii) Consumer Cases	(vii) Matrimonial disputes (except divorce cases);
(viii) DRT Cases	(viii) Land Acquisition cases;
(ix) Karnataka Electricity Regulatory Commission (KERC)- Cases	(ix) Service matters relating to pay and allowance and retiral benefits;
(x) Permanent Lok Adalat Cases	(x) Revenue cases (pending in District Courts and High Courts only);
	(xi) Other Civil cases (rent, easementary rights, injunction suits, specific performance, partition suits) etc.,

**“Advantages of National Lok Adalat”**

- Quick Settlement of cases
- Litigants can approach Lok Adalat either personally or through their Advocates.
- Litigants will be guided suitably in the process of settlement.
- Amicable settlement of cases will resolve the dispute and restore cordial relationship.
- Litigants will have opportunity for settlement of pre-litigation cases before the Lok Adalat.
- There is no need to pay Court fee while filing Pre-litigation Cases.
- If the case is settled before the Lok Adalat, Court fee already paid will be refunded.
- The settlement before Lok Adalat will be done only with the consent of both parties
- Unique opportunity to all the litigants to get their disputes settled in the ongoing National Lok Adalat.
