Ref:- Government Order No.FD-PEN/99/2023, Dated 24.01.2024

It is informed that the Government of Karnataka has issued Government Order under reference wherein it is stated that the Government Employees who have been selected pursuant to the Recruitment Notifications issued prior to 01.04.2006 and joined service on or after 01.04.2006 and wish to come under the "Old Defined Pension Scheme" shall submit their "willingness" in the Proforma prescribed directly to the Competent Authority within 30.06.2024.


The Hon'ble High Court of Karnataka vide letter No.DJA-II 131/2021 Dated 5.2.2024 has informed to forward the consolidated proposal of the Officials working in this unit willing to opt "Old Defined Pension Scheme" along with recommendation on or before 30.06.2024 for forwarding the same to the Government.

In this regard, it is directed that eligible Officials of this Unit who are selected in pursuant to Notifications prior to 01.04.2006 and have joined service on or after 01.04.2006 and covered under "National Pension Scheme" and the Officials selected in pursuant to Notifications prior to 01.04.2006 and have joined service on or after 01.04.2006 in this Department but subsequently selected and appointed to Other departments through Proper Channel are directed to exercise option of joining the "Old Defined Pension Scheme" which was existing prior to 01.04.2006 in terms of conditions issued in the Government Order. It is directed to submit willingness exercising the option **on or before 28th June 2024** to this Office through Tappal Branch for further necessary action. The eligible officials shall submit their willingness in the proforma prescribed by the Government which is enclosed to this Circular. The officials shall submit the documents prescribed in the proforma. The necessary

Recruitment / Selection Notifications will be made available in the Office website "<https://bengaluru.dcourts.gov.in/>". The officials can download the necessary notifications from the above website.

Further, it is informed that in case if any eligible officials do not exercise their option within the prescribed time, it shall be deemed that such eligible officials are not interested in joining "Old Pension Defined Scheme" and that they will be continued in the "National Pension Scheme". The option once exercised is final and irrevocable.
