As per direction of Hon'ble Administrative Judge for CMM Courts unit, Bengaluru at reference Sl.No.1 and in consultation with the Hon'ble Principal City Civil and Sessions Judge, Bengaluru, in exercise of powers conferred under Section 19(3) of Criminal Procedure Code 1973, I **PATIL VEERANAGOUDA SOMASHEKHARAGOUDA**, Chief Metropolitan Magistrate, Bengaluru, do hereby issue this Notification regarding re-allocation of territorial jurisdiction of the Police Stations in the best interest of the Advocate community, Police and the Litigant public, the remapping of the police stations of the Chief Metropolitan Magistrate Courts and Addl. Chief Metropolitan Magistrate Courts as per Annexure-A.

The police stations in Column No.3 of Annexure-A are hereby withdrawn from the courts mentioned in Column No.1 and re-allocated the same as mentioned in Column No.4 of Annexure-A.

This Notification shall come into effect from the forenoon session of 18th March, 2024 and this Notification itself shall be construed to be the notice to the litigant public and their advocates and Sr.APP's with respect to transfer of cases. The transferor courts shall notify the next date of hearing in respect of the cases transferred.

Further, the Police Stations of Bengaluru City Police Commissionerate mentioned in Annexure-A shall submit FIRs and final reports to the re-allocated courts from 18th March, 2024.

Further, all the pending Criminal Cases, FIRs, Final Reports, PCRs and Criminal Miscellaneous cases pertaining to SARFAESI Act as on 18.03.2024 arising out of the said police Stations shall stand transferred to the newly allocated courts as per Annexure A.

Further, it is hereby clarified that all IPC Courts (excluding special designated courts) shall try cases registered by their respective Police stations under the Cyber Crime Laws / Information Technology Act and other offences with respect to Excise Act, NDPS Act, Forest Act and Criminal Miscellaneous pertains to SARFAESI Act and Surrogacy (Regulation) Act 2021 coming under territorial jurisdiction of their respective police stations.

Further, it is hereby clarified that wherever cases already posted for recording of accused statement U/s.313 of Cr.P.C., Final Arguments and reserved for Judgments, the same shall be retained by the said court for disposal as per law.
