2. Along with the submission of quotation, the firms/suppliers are required to furnish the sample of items for the quoted price on the day of Pre-bid meeting which will be held on 23.07.2024, or if declared holiday, on the

next working day. The samples so presented by each bidder will be retained, at the Office of City Civil Court for the purpose of ensuring compliance of quality standards during each delivery of items, until the awarding of tender to the successful bidder, after which the items shall be returned to the respective unsuccessful bidders.

3. Any information and feedback provided on the day of Pre-bid meeting will be collated and an addendum notification will be published through the same means as this notification.
4. No commitments will be made with regard to quantum of purchase of the said items for the whole period of Tender.
5. Upon opening of Financial Bid Cover on the KPP Portal, The Principal District & Sessions Judge, Bengaluru City,
