I am directed to publish through this Corrigendum, as per the orders passed by the Hon'ble Principal City Civil & Sessions Judge, Bengaluru City vide Office Note CCC.ADM.II. 09/2025/(Manpower Outsource-FTSC1234) dated 05.02.2025, the following Correction point, wherever applicable, for kind perusal of the bidders and necessary action in updating their bids.

105. As per the Dept. of Expenditure(Procurement Policy Division), Govt. of India, Office memorandum no. F.6/1/2023-PPD dated 06.01.2023, the Bidders are hereby notified that, they may quote the Service Charge, in INR units between the range 3.85% to 7% on the final total, i.e., Basic+VDA+ESI(Employer)+EPF(Employer)+GST, in INR ₹ only and not in terms of %, as the nature of the work services prescribed in the current Tender involves service charges and expenditures, requiring to prescribe a minimum ceiling, so that it is sustainable on the end of the Service Provider to carry out their business.

Therefore, suitable changes may be made, wherever required, to implement the above, by all the Bidders and **must compulsorily submit a self-declaration**, either to through Tappal Branch of City Civil Court or to the e-mail ID cccadm2@gmail.com and reg.pa.ccc@gmail.com, stating that they have quoted the Service charge not lesser than 3.85%.
